

SCHLENKER DESCRIPTION Parcel No. 1 16.730 ACRE

Commencing at a Monument Box found at the intersection of the centerlines of County Road 168 (Fisher Road) and County Road 117-A (Buckland-River Road);

Thence N.89°11'01"W. along the centerline of County Road 168 and the North line of the South Half of the Northeast Quarter of Section 23, a distance of 835.16 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence S.14°15'07"W. a distance of 1,424.28 feet to an iron pin found, passing thru an iron pin set at 25.70 feet in the South right-of-way line of County Road 168, also passing thru an iron pin found at 199.87 feet;

Thence N.88°57'30"W. a distance of 75.42 feet to a point in the centerline of the Auglaize River;



Thence S.01°33'55"W. along the centerline of County Road 117-A a distance of 272.51 feet to a point;

Thence S.53°34'07"W. along the centerline of County Road 117-A a distance of 752.33 feet to a Cotton Gin Spindle found, which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.53°34'07"E. along the above described line, a distance of 408.10 feet to a P.K. Nail found;
