

SURVEYOR'S DESCRIPTION

The following described tract of land is situated in the Northeast and Southeast Quarters of Section 28, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio, and is more particularly described as follows:

COMMENCING FOR REFERENCE AT A STONE (FOUND) LOCATED AT THE SOUTHWEST CORNER OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 28, MOULTON TOWNSHIP, TOWN-5-SOUTH, RANGE-5-EAST, AUGLAIZE COUNTY, OHIO;

THENCE WITH A BEARING OF N. 02°-07'-47" W. ALONG THE WEST LINE OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 1,668.67 FEET TO A P.K. NAIL/SHINER (FOUND) ON THE CENTERLINE OF TOWNSHIP ROAD #95, KRUSE ROAD;

THENCE CONTINUING WITH A BEARING OF N. 02°-07'-47" W. ALONG THE WEST LINE OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 633.32 FEET TO AN IRON PIN (SET) AND THE PLACE OF BEGINNING;

THENCE CONTINUING WITH A BEARING OF N. 02° –07'–47'' W. ALONG THE WEST LINE OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 324.08 FEET TO AN IRON PIN (FOUND) AT THE NORTHWEST CORNER OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SAID SECTION 28;

THENCE WITH A BEARING OF S. 87° -40'-01'' W. ALONG THE SOUTH LINE OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 662.41 FEET TO AN IRON PIN (FOUND);

THENCE WITH A BEARING OF N. 02°-02'-01" W. ALONG THE WEST LINE OF THE EAST HALF OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 659.34 FEET TO AN IRON PIN (FOUND);

THENCE WITH A BEARING OF N. 87°-39'-45" E. ALONG THE NORTH LINE OF THE SOUTH HALF OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 28 FOR A DISTANCE OF 662.16 FEET TO AN IRON PIN (FOUND);

THENCE WITH A BEARING OF N. $02^{\circ}-03'-20''$ W along the East line of the Southwest Quarter of the Northeast Quarter of said Section 28 for a distance of 331.75 feet to an iron pin (found);

THENCE WITH A BEARING OF N. 87° -24' E. AND PARALLEL WITH THE CENTERLINE OF COUNTY ROAD #158, GLYNWOOD ROAD, FOR A DISTANCE OF 636.53 FEET TO A WOOD END POST (FOUND);

THENCE WITH A BEARING OF S. 02°-04' E. FOR A DISTANCE OF 567.16 FEET TO A POINT LOCATED ON THE CENTERLINE OF A CURVE TO THE LEFT ON TOWNSHIP ROAD #95, KRUSE ROAD, AND PASSING THRU A RAILROAD SPIKE FOUND ON THE FORWARD TANGENT OF SAID CURVE TO THE LEFT AT A DISTANCE OF 565.03 FEET;

THENCE ALONG THE CENTERLINE OF TOWNSHIP ROAD #95 WITH A CURVE TO THE LEFT FOR AN ARC LENGTH OF 49.01 FEET TO A P.K. NAIL/SHINER (FOUND) LOCATED AT THE P.T. OF THE CURVE TO THE LEFT; SAID CURVE HAVING THE FOLLOWING DATA: DELTA $(\triangle) = 09^{\circ}-32'-23''$, RADIUS (R) = 719.06 FEET, AND TANGENT (T) = 60.00 FEET;

THENCE WITH A BEARING OF S. 49°-28'-37" W. ALONG THE CENTERLINE OF TOWNSHIP ROAD #95 FOR A DISTANCE OF 127,10 FEET TO A P.K. NAIL (FOUND) AT THE P.C. OF A CURVE TO THE LEFT;

SURVEYOR'S DESCRIPTION (CONTINUED)

THENCE ALONG THE CENTERLINE OF TOWNSHIP ROAD #95 WITH A CURVE TO THE LEFT FOR AN ARC LENGTH OF 145.91 FEET TO A P.K. NAIL/SHINER (FOUND) LOCATED AT THE P.T. OF THE CURVE TO THE LEFT; SAID CURVE HAVING THE FOLLOWING DATA; DELTA $(\triangle) = 32^{\circ}-40'-42''$, RADIUS (R) = 255.83 FEET, AND TANGENT (T) = 75.00 FEET;

THENCE WITH A BEARING OF S. 16° –47'–55'' W. ALONG THE CENTERLINE OF TOWNSHIP ROAD #95 FOR A DISTANCE OF 557.00 FEET TO A P.K. NAIL/SHINER (SET) AND THE PLACE OF BEGINNING.

CONTAINING IN ALL 24.815 ACRES OF LAND SUBJECT TO ALL LEGAL EASEMENTS, RESERVATIONS, OR RESTRICTIONS, IF ANY, UPON SAID PREMISES. PREVIOUS DEED REFERENCES; VOLUME 161, PAGES 366 AND 490, AUGLAIZE COUNTY RECORDER'S OFFICE.
