Being a parcel of land situated in the Southwest Quarter of Section 29, Township 5 South, Range 5 East, Moulton Township, Auglaize County, Ohio, acquired by George Fisher in Fiduciary Deed recorded in D. V. 223, Page 463 of the Auglaize County, Ohio, deed records and being more particularly described as follows:

Commencing for reference at a chiseled "X" on the lid of a monument box found marking the southwest corner of said Southwest Quarter of Section 29 and the intersection of the centerline of Glynwood-New Knoxville Road (Township Road 81; 40' right of way) with the centerline of Vogel Road (County Road 150; 50' right of way) -

Thence North 00°-18'-44" East (bearing base) on and along the west line of said Southwest Quarter and the centerline of said Glynwood-New Knoxville Road for a distance of 422.85 feet to a mag nail set marking the PRINCIPAL POINT OF BEGINNING for the parcel to be described by this instrument -

Thence continuing North 00° -18'-44" East on and along said west line and said centerline for a distance of 895.98 feet to a mag nail set -

Thence South 89°-35'-20" East for a distance of 1308.88 feet to a 5/8-inch iron rebar set, passing at 30.00 feet a 5/8-inch iron rebar set as reference to the 20.00 feet right of way -

Thence South 00° -25'-01" West for a distance of 1321.55 feet to a 5/8-inch iron rebar set on the south line of said Southwest Quarter -

Thence North 89° -28'-10" West on and along said south line for a distance of 769.01 feet to a 1/2-inch iron pipe found -

Thence North 02°-58'-45" East for a distance of 422.94 feet to a 3/4-inch iron pipe found -

Thence North 89°-26'-23" West for a distance of 557.14 feet to the **place of beginning**, passing a "Jauert" 5/8-inch iron rebar found at 160.12 feet, uncapped 5/8-inch iron rebars found at 259.48 feet and 535.48 feet, and a 5/8-inch iron rebar set at 537.14 feet.

Containing in all 34.321 acres of land, of which 0.411 acres are within the existing road right of way, and being subject, however, to all legal easements and rights of way.

BEGINNING FOR THE SAME at a chiseled "X" on the lid of a monument box found marking the southeast corner of said Southeast Quarter of Section 30 and the intersection of the centerline of Glynwood-New Knoxville Road (Township Road 81; 40' right of way) with the centerline of Vogel Road (County Road 150; 50' right of way) -

Thence North 89°-22'-05" West on and along the south line of said Southeast Quarter and the centerline of said Vogel Road for a distance of 659.36 feet to a mag nail and shiner found -

Thence North 00°-17'-14" East for a distance of 1896.08 feet to a 5/8-inch rebar set, passing at 25.00 feet a "Schnell/PS 7216" 5/8-inch iron rebar found -

Thence North 89°-20'-44" West for a distance of 660.19 feet to a 5/8-inch rebar set -

Thence North 00°-15'-43" East for a distance of 742.05 feet to a "Schnell/PS 7216" 5/8-inch iron rebar found on the north line of said Southeast Quarter -

Thence South 89°-20'-12" East on and along said north line for a distance of 1030.63 feet to a 5/8-inch rebar set -

Thence South 00°-20'-46" West for a distance of 599.84 feet to a point, said point being referenced by an uncapped 5/8-inch iron rebar found North 00°-20'-46" East at a distance of 0.42 feet -

Thence South 89°-29'-16" East for a distance of 290.75 feet to a mag nail set on the east line of said Southeast Quarter and the centerline of Glynwood-New Knoxville Road, passing at 265.40 feet an uncapped 5/8-inch iron rebar found, at 270.75 feet a 5/8-inch iron rebar set, and at 290.40 feet a railroad spike found -

Thence South 00°-18'-44" West (bearing base) on and along the east line of said Southeast Quarter and the centerline of said Glynwood-New Knoxville Road for a distance of 638.00 feet to a mag nail set -

Thence North 89°-41'-16" West for a distance of 290.40 feet to a 5/8-inch iron rebar set, passing at 20.00 feet a 5/8-inch iron rebar set and at 25.00 feet an "S&A Lima OH" 5/8-inch iron rebar found -

Thence South 00°-18'-44" West for a distance of 164.13 feet to an "S&A Lima OH" 5/8-inch iron rebar found -

Thence South 89°-41'-16" East for a distance of 290.40 feet to a mag nail set on the east line of said Southeast Quarter and the centerline of said Glynwood-New Knoxville Road, passing at 265.40 feet an "S&A Lima OH" 5/8-inch iron rebar found and at 270.40 feet a 5/8-inch iron rebar set -


Thence South 00°-18'-44" West on and along said east line and said centerline for a distance of 1236.45 feet to the **place of beginning**.
