## LEGAL DESCRIPTION

Being a part of the east half of the northeast quarter of Section 31, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by OR Volume 289, Page 6 and more particularly described as follows:

Commencing at a monument box (found) at the southeast corner of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road; thence, N 01 degree 52' 54" E along the east line of said northeast quarter and the centerline of Glynwood-New Knoxville Road, for a distance of 217.52 feet to a point (said point being 0.99 feet west of a railroad spike found at the northeast corner of that tract evidenced by OR Volume 375, Page 194) said point also being the **POINT OF BEGINNING** for the tract herein described;

thence, N 89 degrees 33' 01" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 20.00 feet) for a total distance of 399.01 feet to a 5/8" re-rod w/cap (set);

thence, S 01 degree 44' 22" W for a distance of 216.47 feet to a point on the south line of the east half of the northeast quarter of Section 31 (said point referenced by a 1/2" re-rod found 1.53 feet south of said point);

thence, N 89 degrees 24' 08" W along the south line of the east half of the northeast quarter of Section 31, for a distance of 923.69 feet to a 5/8" re-rod w/cap (set) at the southwest corner of the east half of the northeast quarter of Section 31;

thence, N 02 degrees 05' 58" E along the west line of the east half of the northeast quarter, for a distance of 2000.67 feet to a point which is referenced by a 5/8" re-rod (found) 0.23 feet west of said point;

thence, S 89 degrees 13' 07" E for a distance of 673.32' to a 5/8" re-rod (found);

thence, N 00 degrees 38' 13" E (passing through a 5/8" re-rod found at a distance of 621.46 feet, and passing through the south right-of-way line of Vogel Road at a distance of 626.46 feet) for a total distance of 646.46 feet to a railroad spike (found) on the north line of the east half of the northeast quarter of Section 31 and the centerline of Vogel Road;

thence, S 89 degrees 22' 00" E along the north line of the east half of the northeast quarter of Section 31 and the centerline of Vogel Road, for a distance of 655.20 feet to a monument box (found) at the northeast corner of Section 31 and the centerline intersection of Vogel Road and Glynwood-New Knoxville Road:

thence, S 01 degree 52' 54" W along the east line of the east half of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road, for a distance of 652.32 feet to a cotton gin spindle (set);

thence, N 88 degrees 46' 31" W (passing through the west right-of-way line of Glynwood-New Knoxville Road at a distance of 20.00 feet, and a 5/8" re-rod found at a distance of 25.00 feet) for a total distance of 253.52 feet to a 5/8" re-rod (found);

thence, S 00 degrees 05' 41" E for a distance of 609.52 feet to a 5/8" re-rod w/cap (found);

thence, S 89 degrees 42' 55" E (passing through a 5/8" re-rod w/cap found at a distance of 207.57 feet and passing through the west right-of-way line of Glynwood-New Knoxville Road at a distance of 212.57 feet) for a total distance of 232.57 feet to a cotton gin spindle (found) on the east line of the east half of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road:

thence, S 01 degree 52' 54" W along the aforesaid east line and centerline for a distance of 289.32 feet to a cotton gin spindle (found);

thence, N 88 degrees 29' 19" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 20.00 feet) for a total distance of 250.00 feet to a 5/8" re-rod w/cap (found);

thence, S 00 degrees 09' 27" W for a distance of 197.13 feet to a 5/8" re-rod w/cap (found);

thence, S 89 degrees 41' 16" E (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 224.16 feet) for a total distance of 244.16 feet to a cotton gin spindle (found) on the east line of the east half of the northeast quarter of Section 31 and the centerline of Glynwood-New Knoxville Road:

thence, S 01 degree 52' 54" W along the aforesaid east line and centerline, for a distance of 687.84 feet to the **POINT OF BEGINNING**, containing therein 63.618 acres, of which 1.040 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
