

SURVEYOR'S DESCRIPTION Tract One

Being a part of the southeast quarter of Section 31 (north of U.S. Route 33) Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio as evidenced by Official Record Volume 102, Page 192 and more particularly described as follows:

Commencing for reference at a p-k nail (found) at the intersection of the centerline of U.S. Route 33 and the east line of the southeast quarter of Section 31 (also being the legal centerline of Glynwood-New Knoxville Road); thence, along the aforesaid east line and legal centerline, N 02 degrees 05' 38" E for a distance of 399.41 feet to a p-k nail (found) and the **POINT OF BEGINNING** for the tract herein described;

thence, N 89 degrees 24' 24" W (passing through a 5/8" re-rod w/cap found on the westerly right-of-way line of Glynwood-New Knoxville Road at a distance of 99.38 feet) for a total distance of 438.44 feet to a 5/8" re-rod w/cap (found);

thence, S 02 degrees 05' 38" W for a distance of 323.10 feet to a 5/8" re-rod w/cap (found) on the north limited access right-of-way line of U.S. Route 33;

thence, along the aforesaid north limited (L/A) access right-of-way line S 84 degrees 07' 05" W for a distance of 881.28 feet to a point 125 feet left of STATION 403+00;

thence, continuing along the north L/A right-of-way line, S 88 degrees 29' 27" W for a distance of 852.48 feet to a point 190 feet left of STATION 394+50;

thence, continuing along the L/A right-of-way line, N 60 degrees 34' 14" W for a distance of 294.11 feet to a point 360 feet left of STATION 392+10;

thence, continuing along the L/A right-of-way line, N 35 degrees 11' 31"W to a point 645 feet left of STATION 390+50;

thence, continuing along the L/A right-of-way line, N 78 degrees 41' 55" W for a distance of 32.39 feet to a 5/8" re-rod w/cap (found) on the west line of the southeast quarter of Section 31;

thence, N 02 degrees 16' 21" E along the aforesaid west line, for a distance of 499.78 feet to a stone (found) at the northwest corner of the southeast quarter of Section 31;

thence, S 89 degrees 12' 44" E along the north line of the southeast quarter of Section 31 (passing the west right-of-way line of Glynwood-New Knoxville Road at a distance of 2600.78 feet) for a total distance of 2652.21 feet to a monument box (found) at the northeast corner of the southeast quarter of Section 31 and the legal centerline of Glynwood-New Knoxville Road;

thence, S 02 degrees 05' 38" W along the east line of the southeast quarter of Section 31 and the legal centerline of Glynwood-New Knoxville Road, for a distance of 50.00 feet to a p-k nail (found);

thence, N 89 degrees 24' 24" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 56.78 feet) for a total distance of 357.15 feet to a 5/8" re-rod w/cap (found);

thence, S 00 degrees 35' 33" W for a distance of 349.93 feet to a 5/8" re-rod w/cap (found);

thence, S 89 degrees 24' 24" E (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 253.93 feet) for a total distance of 347.98 feet to a p-k nail (found) on the east line of the southeast quarter of Section 31 and the legal centerline of Glynwood-New Knoxville Road;

thence, S 02 degrees 05' 38" W along the aforesaid east line and legal centerline, for a distance of 50.02 feet to the **POINT OF BEGINNING**, containing therein **44.016 acres**, of which 0.173 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument.

Being a part of the southeast quarter of Section 31 (south of U.S. Route 33) Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio as evidenced by Official Record Volume 102, Page 192 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 31 and the legal centerline of Glynwood-New Knoxville Road; thence, N 89 degrees 17' 44" W along the south line of the southeast quarter of Section 31, for a distance of 690.51 feet to a 5/8" re-rod w/cap (found), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the south line of the southeast quarter of Section 31 on a bearing of N 89 degrees 17' 44" W for a distance of 1970.05 feet to a wood corner post (found) at the southwest corner of the southeast quarter of Section 31;

thence, N 02 degrees 16' 21" E along the west line of the southeast quarter of Section 31, for a distance of 1282.20 feet to a 5/8" re-rod w/cap (found) on the south Limited Access (L/A) right-of-way line of U.S. Route 33;

thence, continuing along the south L/A right-of-way line N 63 degrees 47' 42"E for a distance of 3.88 feet to a point 200 feet right of STATION 389+00;

thence, continuing along the south L/A right of way line N 78 degrees 52' 50"E for a distance of 602.51 feet to a point 145 feet right of STATION 395+00;

thence, continuing along the south L/A right-of-way line N 82 degrees 41' 09"E for a distance of 800.25 feet to a point 125 feet right of STATION 403+00;

thence, continuing along the south L/A right-of-way line N 84 degrees 07' 05"E for a distance of 700.00 feet to a point 125 feet right of STATION 410+00;

thence, continuing along the south L/A right-of-way line N 85 degrees 50' 11"E for a distance of 1.00 feet to a 5/8" re-rod w/cap (found);

thence, S 02 degrees 05' 35" W for a distance of 268.90 feet to a 5/8" re-rod w/cap (found);

thence, N 85 degrees 50' 11" E (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Glynwood-New Knoxville Road at a distance of 476.74 feet) for a total distance of 585.58 feet to a cotton gin spindle (found) on the east line of the southeast quarter of Section 31, and the legal centerline of Glynwood-New Knoxville Road;

thence, S 02 degrees 05' 38" W along the aforesaid east line and legal centerline, for a distance of 50.30 feet to a cotton gin spindle (found);

thence, S 85 degrees 50' 11" W (passing through a 5/8" re-rod w/cap found at a distance of 103.79 feet) for a total distance of 585.58 feet to a 5/8" re-rod w/cap (found);

thence, S 02 degrees 05' 35" W for a distance of 566.83 feet to a 5/8" re-rod w/cap (found);

thence, S 89 degrees 13' 35" E for a distance of 182.22 feet to a 1" pinch pipe (found);

thence, S 02 degrees 05' 35" W for a distance of 563.15 feet to a 5/8" re-rod w/cap (found);

thence, N 89 degrees 17' 44" W for a distance of 290.49 feet to a 5/8" re-rod w/cap (found);

thence, S 02 degrees 05' 35" W for a distance of 150.00 feet to the **POINT OF BEGINNING**, containing therein **72.299 acres**, of which 0.122 acres is road right-of-way. Subject to all easements and right-of-ways of record at the time of the recording of this instrument.

The combined total gross acreage for Tract One and Tract Two is 116.315 acres.
