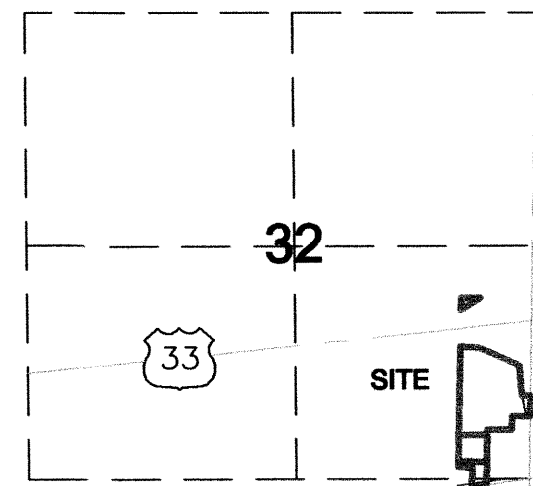

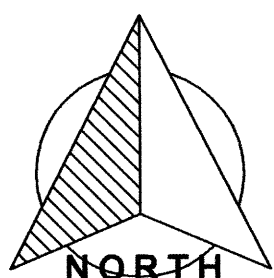

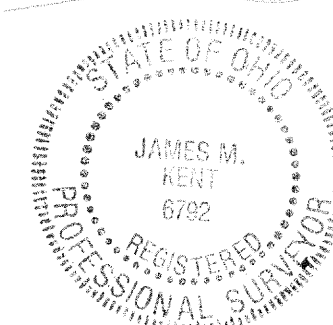
GRAPHIC SCALE

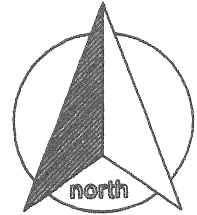

SURVEYOR'S DESCRIPTION

Being a part of Lot 7 of the Subdivision of Section 32, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 521, Page 675 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 32; thence, N 01° 12' 46" E along the east line of the southeast quarter of Section 32 and the legal centerline of Moulton-Ft. Amanda Road for a distance of 730.57 feet to a p-k nail (found) at the intersection of the aforesaid east line and legal centerline, with the centerline of County Road 33-A; thence, S 81° 30' 26" W along the centerline of County Road 33-A for a distance of 460.99 feet to a mag-nail (found); thence, with a bearing of N 01° 21' 55" E, (passing through a 5/8" re-rod w/cap found on the north right-of-way line of County Road 33-A at a distance of 40.60 feet) for a total distance of 246.91 feet to a 5/8" re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, N 88° 41' 29" W for a distance of 302.26 feet to a 5/8" re-rod w/cap (set);

thence, N 01° 21' 55" E for a distance of 339.54 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 13' 56" E for a distance of 302.28 feet to a 5/8" re-rod w/cap (set);


thence, S 01° 21' 55" W for a distance of 342.40 feet to the **POINT OF BEGINNING**, containing therein **2.366 acres**. 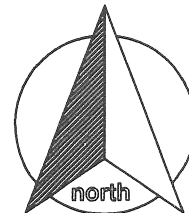

Being a part of Lot 7 and Lot 8 of the Subdivision of Section 32, Town-5-South, Range-5-East, Moulton Township, Auglaize County, Ohio as evidenced by Official Record Volume 521, Page 675 and more particularly described as follows:

Commencing for reference at a p-k nail (found) at the intersection of the centerlines of County Road 33-A and Moulton-Ft. Amanda Road and the east line of the southeast quarter of Section 32; thence, N 01° 13' 17" E along the legal centerline of Moulton-Ft. Amanda Road and the aforesaid east line for a distance of 658.03 feet to a mag-nail (found), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 89° 08' 03" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Moulton-Ft. Amanda Road at a distance of 40.88 feet) for a total distance of 195.00 feet to a 5/8" re-rod w/cap (found);

thence, S 01° 13' 17" W for a distance of 143.25 feet to a 1/2" re-rod (found);

thence, N 89° 13' 56" W for a distance of 560.19 feet to a 5/8" re-rod w/cap (found);

thence, N 01° 21' 55" E for a distance of 878.26 feet to a 5/8" re-rod w/cap (found) on the southerly Limited Access Boundary line of United States Route 33;

thence, with the following courses on the aforesaid Limited Access Boundary line; S 85° 20' 28" E for a distance of 205.02 feet to a 5/8" re-rod w/cap (found);

S 65° 57' 47" E for a distance of 461.41 feet to a 5/8" re-rod w/cap (found);

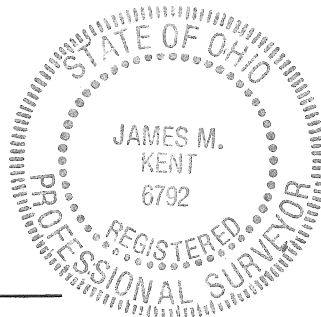
