thence S 89 degrees 36' 16" W, along the South line of said Section 8 (passing through a 5/8" re-rod set on the westerly right-of-way line of SR 116 at a distance of 30.00 feet) for a total distance of 2,671.38 feet to a 5/8" re-rod w/cap (set) at the South quarter corner of said Section 8:

thence N 00 degrees 05' 09" W, along the West line of the Southeast quarter of Section 8, for a distance of 1,323.41 feet to a 5/8" re-rod w/cap (set) at the Northwest corner of the South half of the Southeast quarter of said Section 8;





thence N 00 degrees 12' 45" W, along the East line of the Southeast quarter of said Section 8 and the centerline of SR 116, for a distance of 300.20 feet to a Cotton Gin Spindle (set) and the PLACE OF BEGINNING;

thence S 89 degrees 36' 16" W (passing through a 5/8" re-rod w/cap set on the westerly right-of-way line of SR 116 at a distance of 30.00 feet), for a total distance of 2,220.05 feet to a 5/8" re-rod w/cap (set);


