TRACT "A" LEGAL DESCRIPTION

Being a part of the east half of the northwest quarter and a part of the west half of the west half of the northeast quarter of Section 14, T-5-S, R-4-E, Noble Township, Auglaize County, Ohio lying south of the Delphos-St. Marys Road as evidenced by Deed Volume 169, Page 251 and being more particularly described as follows:

Commencing at a stone (as referenced by Sandkuhl Survey by Kohli & Kaliher, 1986) located at the southwest corner of the east half of the northwest quarter of Section 14, and the legal centerline of Schillinger Road; thence, N 01 degree 11' 11" E along the west line of the east half of the northwest quarter of said Section 14 and the legal centerline of Schillinger Road, for a distance of 878.32 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described:

thence, continuing N 01 degree 11' 11" E along the aforesaid west line and legal centerline, for a distance of 548.00 feet to a monument box (found) at the intersection of the aforesaid west line, legal centerline of Schillinger Road and the legal centerline of Delphos-St. Marys Road (Old State Route 66);

thence, N 62 degrees 34' 07" E along the legal centerline of Delphos-St. Marys Road, for a distance of 1224.24 feet to a cotton gin spindle (set) at a point of curve:

thence, along the centerline of Delphos-St. Marys Road on a tangent curve to the left (concave to the northwest), having a radius of 1292.00 feet, a central angle of 17 degrees 16' 32", a chord which bears N 53 degrees 55' 48" E and measures 388.089 feet, for a total arc length of 389.56 feet to a cotton gin spindle (set) at a point of tangency;

thence, continuing along the centerline of Delphos-St. Marys Road N 45 degrees 17' 34" E, for a distance of 594.07 feet to a cotton gin spindle (set) on the north line of the northeast quarter of Section 14;

thence, S 89 degrees 32' 09" E along the north line of the west half of the west half of the northeast quarter of said Section 14 (passing through a 5/8" rerod w/cap set on the easterly right-of-way line of Delphos-St. Marys Road at a distance of 41.64 feet) for a total distance of 187.05 feet to the northeast corner of the west half of the west half of the northeast quarter of Section 14;

Commencing at a stone (as referenced by Sandkuhl Survey by Kohli & Kaliher, 1986) located at the southwest corner of the east half of the northwest quarter of Section 14, and the legal centerline of Schillinger Road; thence, N 01 degree 11' 11" E along the west line of the east half of the northwest quarter of said Section 14 and the legal centerline of Schillinger Road, for a distance of 1426.32 feet to a monument box (found) at the intersection of the aforesaid west line, legal centerline of Schillinger Road and the legal centerline of Delphos-St. Marys Road (Old State Route 66); thence, N 62 degrees 34' 07" E along the legal centerline of Delphos-St. Marys Road, for a distance of 1224.24 feet to a cotton gin spindle (set) at a point of curve; thence, along the centerline of Delphos-St. Marys Road on a tangent curve to the left (concave to the northwest), having a radius of 1292.00 feet, a central angle of 9 degrees 29' 10", a chord which bears N 57 degrees 49' 32" E and measures 213.67 feet, for a total arc length of 213.91 feet to a cotton gin spindle (set), said spindle being the POINT OF BEGINNING for the tract herein described;

Commencing at a cotton gin spindle (set) at the southwest corner of the east half of the southwest quarter of Section 11, and the legal centerline of Schillinger Road: thence, S 89 degree 32' 09" E along the south line of Section 11 (passing the south quarter corner of said Section 11 at a distance of 1324.92 feet) for a total distance of 1800.32 feet to a cotton gin spindle (set) on the legal centerline of Delphos-St. Marys Road; thence, N 45 degrees 17' 34" E along the legal centerline of said Delphos - St. Marys Road, for a distance of 441.41 feet to a cotton gin spindle (set), said spindle being the POINT OF BEGINNING for the tract herein described:
