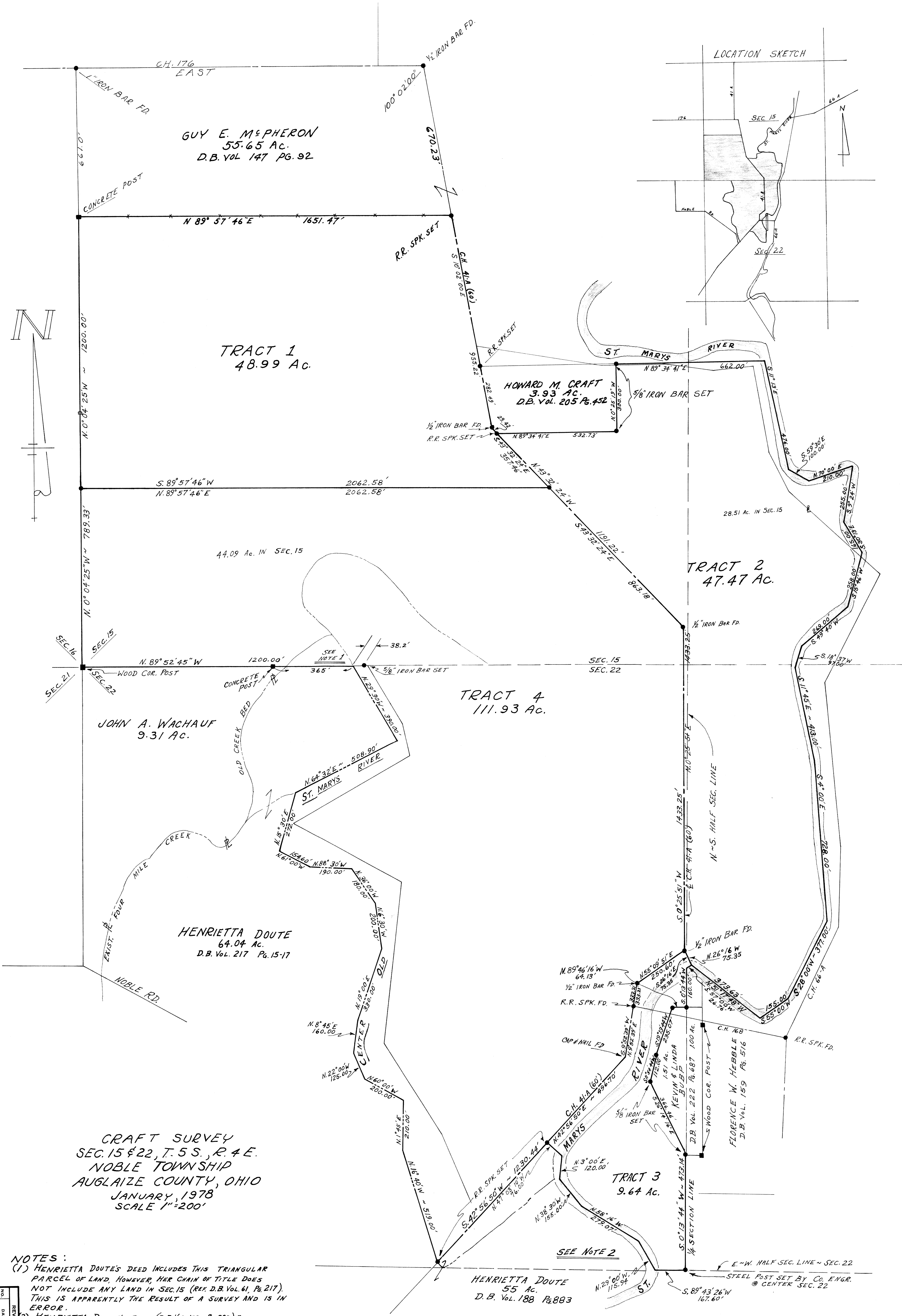
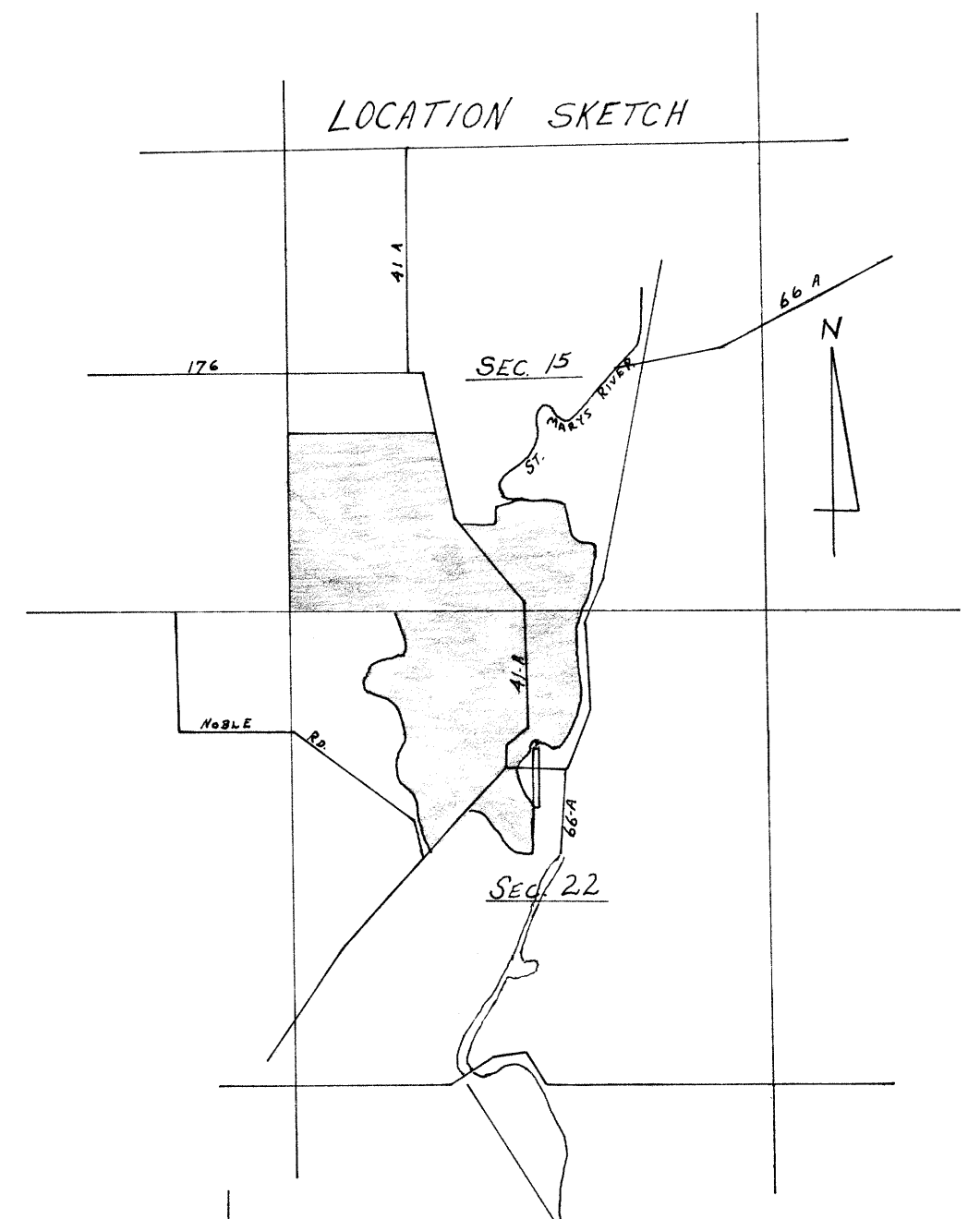


NOT TO SCALE

- (1) HENRIETTA DOUTE'S DEED INCLUDES THIS TRIANGULAR PARCEL OF LAND, HOWEVER, HER CHAIN OF TITLE DOES NOT INCLUDE ANY LAND IN SEC. 15 (REF. D.B. Vol. 61, Pg. 217). THIS IS APPARENTLY THE RESULT OF A SURVEY AND IS IN ERROR.
- (2) HENRIETTA DOUTE'S DEED (D.B. Vol. 188, Pg. 883) FOR THIS PARCEL INCLUDES NO LAND IN THE NORTH HALF OF SEC. 22. HOWEVER, THIS LAND HAS BEEN USED AND OCCUPIED BY THE DOUTE FARM FOR MANY YEARS, EVEN THOUGH DOUTE HAS NO TITLE TO THIS LAND. THIS SURVEYOR FEELS THAT ADVERSE POSSESSION IS A POSSIBILITY. LEGAL ADVICE IS RECOMMENDED AND, IF LITIGATION DESIRED, MORE SURVEYING IS NEEDED.
