
ANNEXATION TO THE CITY OF ST. MARYS



DESCRIPTION:

being part of the southeast quarter of Section 32, and part of the southwest quarter of Section 33, Town-5-South, Range-4-East, Noble Township, Auglaize County, Ohio, and being more particularly described as follows:

Commencing at the southeast corner of Section 32, this point also being the PLACE OF BEGINNING, Thence, North 88°58'50" West, along the south line of said Section 32, said line also being the south line of a tract of land as conveyed to Yorkshire, Inc., by official records Volume 80, Page 112, of the Auglaize County Recorder's records, a distance of one thousand three hundred six and 55/100 (1306.55) feet to a point, said point being the southwest corner of the said Yorkshire, Inc. tract;

Thence, North 01°23'54" East, along the west line of said Yorkshire, Inc., tract, a distance of one thousand two hundred seventy-six and 48/100 (1276.48) feet to a point, said point being on the south limited access right-of-way line of the State Route #29 and U.S. Route #33 interchange;

Thence, along the said south limited access right-of-way line of the State Route #29 and U.S. Route #33 interchange the following courses and distances:

South 88° 35' 05" East - 73.23 feet to a point; South 74° 45' 22" East - 334.70 feet to a point; South 57° 37' 15" East - 262.39 feet to a point; South 49° 09' 25" East - 582.58 feet to a point; South 69° 15' 48" East - 327.51 feet to a point; South 89° 16' 46" East - 277.22 feet to a point; North 74° 00' 01" East - 356.41 feet to a point; South 83° 49' 32" East - 180.28 feet to a point; South 61° 26' 46" East - 203.96 feet to a point; South 51° 34' 04" East - 475.14 feet to a point; said point being the northwest corner of a tract of land as conveyed to the Marathon Oil Company by deed Volume 210, Page 334, of the Auglaize County Recorder's records;

Thence, South 06°11'49" West, along said west line of the Marathon Oil Company tract, a distance of two hundred eighty and 78/100 (280.78) feet to a point on the south line of Section 33 (Noble Township), said point also being the southwest corner of said Marathon Oil Company tract;

Thence, North $89^{\circ}00^{\circ}00^{\circ}00^{\circ}$ West, along said south line of Section 33, Noble Township, a distance of one thousand four hundred ten and 25/100 (1410.25) feet to the PLACE OF BEGINNING.

Containing 48.12 acres of land more or less.
