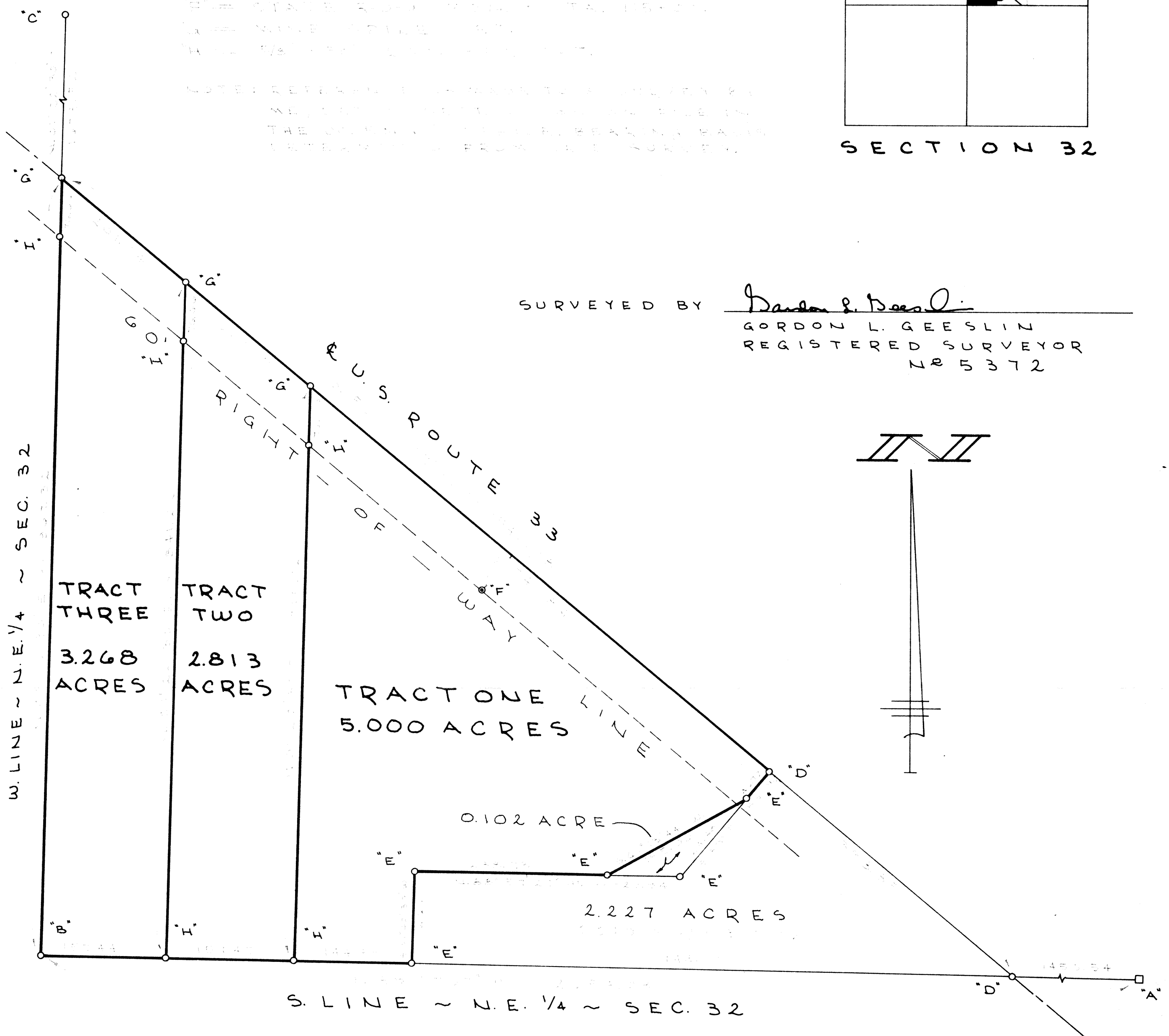

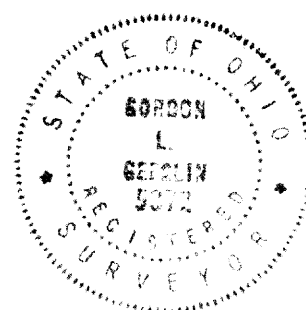

HOLLENBACHER SURVEY DESCRIPTION (TRACT ONE)

Being a parcel of land situated in Noble Township, ^{Aug 1992} Mercer County, Ohio, in the west half of the northeast quarter of Section 32, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the southeast corner of the northeast quarter of said Section 32-

Thence, north 88°57'27" west, along the south line of the northeast quarter of said Section 32, a distance of two thousand one hundred ninety-eight and 54/100 (2198.54) feet to a 5/8 inch iron bar at the southwest corner of a 2.240 acre tract of land conveyed to Norman and Patricia Gottschalk by deed recorded in Deed Volume 172, page 687. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, north 88°57'27" west, along the last described line, a distance of one hundred forty-four and 85/100 (144.85) feet to a 5/8 inch iron bar-

Thence, north 01°22'30" east, a distance of seven hundred fifteen and 12/100 (715.12) feet to a mine spike in the centerline of U.S. Route 33-

Thence, south 50°08'07" east, along the centerline of said U.S. Route 33, a distance of seven hundred forty-one and 84/100 (741.84) feet to a railroad spike at the most northern point of said 2.240 acre tract of land-

Thence, south 39°51'53" west, along a line of said 2.240 acre tract of land, a distance of forty-six and 72/100 (46.72) feet to a 5/8 inch iron bar at the northeast corner of a 0.102 acre triangular tract of land conveyed to Norman and Patricia Gottschalk by deed recorded in Official Record 22, page 844-

Thence, south 61°13'44" west, along the north line of said 0.102 acre triangular tract of land, a distance of one hundred ninety-five and 06/100 (195.06) feet to a 5/8 inch iron bar at the southwest corner of said 0.102 acre triangular tract of land and also being in a line of said 2.240 acre tract of land-

Thence, north 88°57'27" west, along a line of said 2.240 acre tract of land, a distance of two hundred thirty-eight and 73/100 (238.73) feet to a 5/8 inch iron bar-

Thence, south 01°02'33" west, along the west line of said 2.240 acre tract of land, a distance of one hundred sixteen and 66/100 (116.66) feet to the place of beginning.

Thence, north 88°57'27" west, along the south line of the northeast quarter of said Section 32, a distance of two thousand three hundred forty-three and 39/100 (2343.39) feet to a 5/8 inch iron bar. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, north 88°57'27" west, along the last described line, a distance of one hundred fifty-seven and 45/100 (157.45) feet to a 5/8 inch iron bar-

Thence, north 01°22'30" east, a distance of eight hundred forty-one and 22/100 (841.22) feet to a mine spike in the centerline of U.S. Route 33-

Thence, south 50°08'07" east, along said centerline of U.S. Route 33, a distance of two hundred one and 15/100 (201.15) feet to a mine spike-

Thence, south 01°22'30" west, a distance of seven hundred fifteen and 12/100 (715.12) feet to the place of beginning.
