Commencing for reference at a 5/8 inch iron bar at the northwest corner of the southeast quarter of the southeast quarter of said Section 33-

Thence, south 01°22'52" west, along the west line of said southeast quarter of the southeast quarter, a distance of three hundred twenty-one and 05/100 (321.05) feet to a point. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing south $01^{\circ}22'52"$ west, along the last described line, a distance of three hundred twenty and 38/100 (320.38) feet to a 5/8 inch iron bar-

Thence, south 88°42'42" east, a distance of five hundred (500.00) feet to a 5/8 inch iron bar-

Thence, north 01°22'52" east, a distance of one hundred fifty-three (153.00) feet to a 5/8 inch iron bar-

Thence, north 69°22'05" east, a distance of two hundred fifty and 90/100 (250.90) feet to a mine spike in the former centerline of State Route 116-

Thence, north 19°55'40" west, along said former centerline of State Route 116, a distance of ninety-eight and 42/100 (98.42) feet to a mine spike-

Thence, south 89°48'21" west, a distance of six hundred ninety-seven and 10/100 (697.10) feet to the place of beginning.

Containing 4.443 acres of land more or less.

Beginning at a 5/8 inch iron bar at the northwest corner of the southeast quarter of the southeast quarter of said Section 33-

Thence, north 01°22'52" east, along the west line of said Lot Number 5 of Buehler's Subdivision, a distance of one hundred eighty-one and 25/100 (181.25) feet to a 5/8 inch iron bar in the south limited access right-of-way line of U.S. Route 33-

Thence, north 89°38'06" east, along said limited access right-of-way line, a distance of five hundred two and 65/100 (502.65) feet to a mine spike in the centerline of State Route 116-

Thence, south 19°55'40" east, along said centerline of State Route 116, a distance of two hundred seven and 68/100 (207.68) feet to a mine spike-

Thence, north 88°55'28" west along the north line of the southeast quarter of the southeast quarter of said Section 33, a distance of five hundred seventy-seven and 89/100 (577.89) feet to the place of beginning.
