

FORTMAN SURVEY DESCRIPTION

Being a parcel of land situated in Noble Township, Auglaize County, Ohio in the south half of Section 34, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the southeast corner of said Section 34 -

Thence, North 88°51'27" West, along the south line of said Section 34 and the centerline of McKinley Road, a distance of 1451.34 feet to a P.K. nail found at the intersection of said section line and State Route 66 -

Thence, North 88°54'59" West, along the south line of said Section 34, a distance of 80.09 feet to a 5/8 inch iron bar. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, North 88°54'59" West, along the last described line, a distance of 2457.77 feet to a 5/8 inch iron bar -

Thence, North 02°28'42" West, along the State of Ohio property line, a distance of 103.29 feet to a 5/8 inch iron bar -

Thence, North 12°14'48" East, along the State of Ohio property line, a distance of 173.75 feet to a 5/8 inch iron bar -

Thence, North 25°25'21" East, along the State of Ohio property line, a distance of 609.48 feet to a 5/8 inch iron bar -

Thence, North 28°02'05" East, along the State of Ohio property line, a distance of 173.34 feet to a 5/8 inch iron bar -

Thence, North 41°45'28" East, along the State of Ohio property line, a distance of 406.46 feet to a 5/8 inch iron bar -

Thence, South 83°08'42" East, a distance of 507.14 feet to a 5/8 inch iron bar -

Thence, South 81°54'17" East, a distance of 222.27 feet to a 5/8 inch iron bar -

Thence, South 81°50'36" East, a distance of 695.18 feet to a 5/8 inch iron bar -

Thence, South 68°01'41" East, a distance of 420.00 feet to a 5/8 inch iron bar -

Thence, South 49°00'12" East, a distance of 319.90 feet to a 5/8 inch iron bar -

Thence, South 08°02'13" West, a distance of 305.82 feet to a 5/8 inch iron bar -

Thence, South 22°04'09" West, a distance of 424.78 feet to a 5/8 inch iron bar -

Thence, South 22°00'00" West, a distance of 77.88 feet to the place of beginning.
