

LEGAL DESCRIPTION TRACT 1- 73.996 ACRES

SITUATED IN THE TOWNSHIP OF NOBLE, COUNTY OF AUGLAIZE, STATE OF OHIO IN THE SOUTHWEST QUARTER OF SECTION 35, TOWNSHIP 5 SOUTH, RANGE 4 EAST, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Beginning at an iron bar in a monument box found at the northeast corner of the southwest quarter of Section 35, also being on the centerline of Shipman Road;

thence, South 00° -54'-23" West, 1324.45 feet, along the east line of said quarter to an iron pin with cap set on the northerly line of U.S. Route 33, passing for reference an iron pin with cap set at 15.00 feet;

thence, North 89°-09'-23" West, 1502.80 feet, along the northerly line of said U.S. Route 33 to an iron pin with cap set;

thence, North 87°-26'-17" West, 500.22 feet, along the northerly line of said U.S. Route 33 to an iron pin with cap set;

thence, North 77°-50'-48" West, 509.91 feet, along the northerly line of said U.S. Route 33 to an iron pin with cap set;

thence, North 56°-09'-50" West, 171.47 feet, along the northerly line of said U.S. Route 33 to a point on the west line of said southwest quarter section, witness an iron pin found South 01°-26'-32" West, 1.46 feet from corner;

thence, North 01°-26'-32" East, 340.70 feet, along the west line of said quarter section to a point on the existing southerly right-of-way line of State Route 66, witness an iron pin found North 01°-26'-32" East, 1.13 feet from corner;

thence, North 39°-20'-56" East, 93.18 feet, along the existing southerly right-of-way line of said State Route 66 to an iron pin with cap set;

thence, North 44°-11'-45" West, 78.98 feet, to a P.K. nail set on the centerline of State Route 66;


thence, North 46°-16'-52" East, 917.76 feet, along the centerline of said State Route 66 to a P.K. nail set on the centerline of Shipman Road, also being on the north line of the said southwest quarter of Section 35;

thence, South 89°-14'-02" East, 1988.51 feet, along the centerline of said Shipman Road and the north line of said quarter section to the place of beginning.

Containing 73.996 acres more or less of which acres more or less being within existing road right-of-way with all being subject to any legal highways and easements of record.

LEGAL DESCRIPTION TRACT 2- 0.694 ACRES

SITUATED IN THE TOWNSHIP OF NOBLE, COUNTY OF AUGLAIZE, STATE OF OHIO IN THE SOUTHEAST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 4 EAST, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commencing for reference at an iron bar in a monument box found at the northeast corner of the southeast quarter of Section 34, also being on the centerline of County Road 66-A;

thence, South 01°-26'-32" West, 771.87 feet, along the east line of said quarter to a point on the existing southerly right-of-way line of State Route 66, witness an iron pin found North 01°-26'-32" East, 1.13 feet from corner and being the principal place of beginning for the tract herein conveyed;

thence, South 01°-26'-32" West, 340.70 feet, along the east line of said quarter section to a point on the northerly line of U.S. Route 33, witness an iron pin found South 01°-26'-32" West, 1.46 feet from corner;

thence, North 56°-09'-50" West, 210.29 feet, along the northerly line of said U.S. Route 33 to an iron pin with cap set on the existing southerly right-of-way line of said State Route 66;

thence, North 39°-20'-56" East, 289.02 feet, along the existing southerly right-of-way line of said State Route 66 to the principal place of beginning.

Containing 0.694 acres more or less with all being subject to any legal highways and easements of record.
