Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 2, (also being the centerline intersection of Brown Road and Weimert School Road; thence, N 89 degrees 34' 43" W along the legal centerline of Weimert School Road and the south line of the southeast quarter of Section 2, for a distance of 471.05 feet to a monument box (found) at the intersection of Weimert School Road and Wapak-Fisher Road; thence, N 56 degrees 34' 23" W along the legal centerline of Wapak-Fisher Road, for a distance of 1010.98 feet to a cotton gin spindle (set) on the east line of the west half of the southeast quarter of Section 2, said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing **N** 56 degrees 34' 23" W along the aforesaid legal centerline, for a distance of 59.10 feet to a cotton gin spindle (set);

thence, N 01 degree 12' 48" E for a distance of 1147.47 feet to a 5/8" re-rod w/cap (set);

thence, N 67 degrees 53' 58" W for a distance of 701 67 feet to a 5/8" re-rod w/cap (set);

thence, S 01 degree 17' 41" W for a distance of 16.05 feet to the former southerly right-of-way of the New York Central Railroad;

thence, N 67 degrees 53' 58" W along the aforesaid former southerly right-of-way, for a distance of 127.98 feet to a 5/8" re-rod w/cap (set);

thence, leaving the aforesaid ditch S 89 degrees 53' 32" E (passing through a 5/8" re-rod w/cap set for reference at a distance of 50.00 feet) for a total distance of 957.54 feet to a 5/8" re-rod w/cap set at the northeast corner of the west half of the southeast quarter of Section 2;

thence, S 01 degree 12' 48" W along the east line of the west half of the southeast quarter of Section 2 (passing through a 5/8" re-rod w/cap set on the northerly right-of-way line of Wapak-Fisher Road at a distance of 2076.35 feet) for a total distance of 2105.90 feet to the **POINT OF BEGINNING**, containing therein 20.180 acres, of which 0.437 acres is road right-of-way. Commencing for reference at a monument box (found) at the southeast corner of the southeast quarter of Section 2, (also being the centerline intersection of Brown Road and Weimert School Road; thence, N 89 degrees 34' 43" W along the legal centerline of Weimert School Road and the south line of the southeast quarter of Section 2, for a distance of 471.05 feet to a monument box (found) at the intersection of Weimert School Road and Wapak-Fisher Road; thence, N 56 degrees 34' 23" W along the legal centerline of Wapak-Fisher Road, for a distance of 2534.29 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing N 56 degrees 34' 23" W along the aforesaid legal centerline, for a distance of 42.47 feet to a monument box (found) on the west line of the west half of the southeast quarter of Section 2;
