



SURVEYOR'S DESCRIPTION

scale:

Being a part of the west half of Section 2, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio as evidenced by Deed Volume 235, Page 485 (parcel #l2500200300) and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the west half of Section 2 and the legal centerline of Weimert-School Road; thence, N 89º 50' 15" W along the south line of the southwest quarter of Section 2 and the legal centerline of Weimert-School Road for a distance of 1323.82 feet to a mag-nail (set), said nail being the POINT OF BEGINNING for the tract herein described;

Thence, continuing along the aforesaid south line and centerline of Weimer-School Road N 89º 50' 15" W, for a distance of 1323.82 feet to a monument box (found) at the southwest corner of Section 2 and the legal centerline of Wapak-Freyburg Road;

Thence, N 01º 12' 23" E along the west line of the southwest quarter of Section 2 and the legal centerline of Wapak-Freyburg Road for a distance of 2650.22 feet to a mag-nail (set) at the west quarter corner of Section 2;

Thence, N 01º 07' 21" E along the aforesaid centerline and the west line of the northwest quarter of Section 2 for a distance of 489.53 feet to a monument box (found) on the centerline of Wapak-Fisher Road;

Thence, S 56º 27' 39" E along the legal centerline of Wapak-Fisher Road (passing from the northwest quarter into the southwest quarter at a distance of 884.25 feet) for a total distance of 1569.28 feet to a mag-nail (set);

Thence, S 01º 14' 53" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Wapak-Fisher Road at a distance of 29.57 feet and a 5/8" re-rod w/cap set for reference at a distance of 2251.33 feet) for a total distance of 2276.33 feet to the POINT OF BEGINNING, containing therein 82.341 acres, of which 4.195 acres lay in the northwest quarter, 78.147 acres lay in the southwest quarter and 3.235 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. This instrument prepared by James M.
