LEGAL DESCRIPTION

Being a part of the northwest fractional quarter of Section 6, Town-6-South, Range-6-East, Pusheta Township, Auglaize County, Ohio as evidenced by Deed Volume 230, Page 55 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the northwest fractional quarter of Section 6 and the legal centerline of Canning Factory Road; thence, S 89 degrees 41' 58" E along the north line of the northwest fractional quarter of said Section 6 and the legal centerline of Canning Factory Road, for a distance of 301.16 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid north line and legal centerline S 89 degrees 41' 58" E for a distance of 660.00 feet to a cotton gin spindle (set);

thence, S 00 degrees 18' 02" W (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Canning Factory Road at a distance of 25.00 feet) for a total distance of 1320.00 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 41' 58" W for a distance of 660.00 feet to a 5/8" re-rod w/cap (set);

thence, N 00 degrees 18' 02" E (passing through a 5/8" re-rod w/cap set on the south right-of-way line of Canning Factory Road at a distance of 1295.00 feet) for a total distance of 1320.00 feet to the **POINT OF BEGINNING**, containing therein 20.000 acres, of which 0.378 acres is road right-of-way.
