Commencing at a monument box over a stone (found) at the South quarter corner of said Section 15 and the centerline of Fryburg Drive; thence with an assumed bearing of S 89 degrees 30' 22" E, along the aforesaid centerline and South line of the West one-half of the southeast quarter of Section 15, for a distance of 391.14 feet to a cotton gin spindle (set), said spindle being the POINT OF BEGINNING for the tract herein described;


