Commencing at a p-k nail (found) at the intersection of the East line of the West half of Section 19, and the centerline of Headapohl Road; thence, S 00 degrees 53' 04" W along the aforesaid East line (passing thorough an iron pin w/cap found at a distance of 827.47 feet) for a total distance of 891.00 feet to the southeast corner of the northwest quarter of Section 19; thence, N 89 degrees 04' 48" W along the South line of the northwest quarter of Section 19, for a distance of 655.38 feet to the southwest corner of the East half of the East half of the northwest quarter of Section 19, said point being the POINT OF BEGINNING for the tract herein described;

thence, N 00 degrees 56' 06" E for a distance of 545.44 feet to the centerline of Headapohl Road:

thence, S 86 degrees 00' 09" E along the aforesaid centerline of Headapohl Road, for a distance of 9.01 feet to a cotton gin spindle (set);

thence, S 00 degrees 56' 06" W, (passing through a 5/8" re-rod set for reference at a distance of 30.00 feet and the South line of the northwest quarter at a distance of 544.95 feet) for a total distance of 545.89 feet to a 5/8" re-rod w/cap (set);


