

DESCRIPTION JOB #22455 **26.930 ACRES**

Being Tax Parcel J27-023-008-00 situated in the Southeast Quarter of Section 23, Township 4 South, Range 4 East, Salem Township, Auglaize County, Ohio, acquired by Rex E. Shaffer and Dorothy K. Shaffer in Warranty Deed recorded in O. R. 438, Page 1065, of the Auglaize County, Ohio, deed records and being more particularly described as follows:

Commencing for reference at a one-inch iron pin under the lid of a monument box found marking the southeast corner of the Southeast Quarter of Section 23 and the centerline of Township Road 220, also being I. O. O. F. Road -

Thence South 89°-38'-50" West on and along the south line of said Southeast Quarter for a distance of 1160.72 feet to a 5/8-inch iron pin set marking the PRINCIPAL POINT OF BEGINNING for the parcel to be described by this instrument -

Thence continuing South 89°-38'-50" West on and along the south line of said Southeast Quarter for a distance of 1503.72 feet to a 5/8-inch iron pin found for the South Quarter Post of Section 23, passing at 70.00 feet a 5/8-inch iron pin set for reference -

Thence North 00°-17'-41" East on and along the west line of said Southeast Quarter for a distance of 1002.23 feet to a 5/8-inch iron pin set -

Thence North 89°-30'-06" East for a distance of 843.00 feet to a 5/8-inch iron pin set on the west line of the Miami and Erie Canal, passing at 787.00 feet a 5/8-inch iron pin set for reference -

Thence on and along said west line of the Miami and Erie Canal with the following three (3) courses:

- South 32°-40'-20" East for a distance of 657.87 feet to a 5/8-inch iron pin set -1)
- South 33°-43'-39" East for a distance of 526.54 feet to a 5/8-inch iron pin set -2)
- South 43°-12'-09" East for a distance of 11.79 feet to the place of beginning. 3)

Containing in all 26.930 acres of land subject, however, to all legal easements and rights of way.

The foregoing description is based on a field survey completed September 3, 2002, under the supervision of Ohio Registered Professional Surveyor James D. Sheldon (#4569).

NOTES: 1) Bearings are based on the south line of Section 24 between monument boxes found for the Southeast corner of Section 23 and the South 1/4 Post of Section 24 as being North 90°-00'-
