SURVEYOR'S DESCRIPTION

Being a part of the east half of the northwest quarter of Section 32, Town-4-South, Range-4-East, Salem Township, Auglaize County, Ohio as evidenced by Official Record Volume 127, page 1 and more particularly described as follows:

Commencing for reference at an iron bar (found) at the north quarter post of Section 32; thence, S 00° 18′ 02″ E along the east line of the northwest quarter of Section 32 for a distance of 460.01 feet to a 5/8″ re-rod w/cap (set), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

Thence, continuing along the aforesaid line S 00° 18′ 02″ E (passing through a 5/8″ re-rod w/cap set on the north right-of-way line of Hesse Road at a distance of 289.75 feet) for a total distance of 309.75 feet to a mag-nail (set) on the centerline of Hesse Road;

Thence, N 86° 08′ 14″ W along the aforesaid centerline for a distance of 728.79 feet to a mag-nail (set);

Thence, N 01° 45′ 24″ E (passing through a 5/8″ re-rod w/cap set on the north right-of-way line of Hesse Road at a distance of 20.01 feet) for a total distance of 281.63 feet to a 5/8″ re-rod w/cap (set);

Thence, N 73° 35′ 02″ E for a distance of 170.32 feet to a 5/8″ re-rod w/cap (set);

Thence, S 82° 53′ 37″ E for a distance of 557.79 feet to the **POINT OF BEGINNING**, containing therein **5.339 acres** of which 0.335 acres is road right-of-way. SURVEYOR'S DESCRIPTION

Being a part of the east half of the northwest quarter of Section 32, and a part of the southwest quarter of Section 29, Town-4-South, Range-4-East, Salem Township, Auglaize County, Ohio as evidenced by Official Record Volume 127, page 1 and more particularly described as follows:

Commencing for reference at a rail road spike (found) on the centerline of Hesse Road and the west line of the east half of northwest quarter of Section 32; Thence, along the centerline of Hesse Road on a curve which is concave to the north, said curve having a central angle which measures 05° 45′ 49″, a radius which measures 2224.59 feet, a chord which bears S 83° 15′ 20″ E and a chord which measures 223.68 feet for a total arc length of 223.78 feet to a railroad spike (found) at a point of tangency; thence, continuing along the centerline of Hesse Road S 86° 08′ 14″ E for a distance of 26.68 feet to a boat spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

Thence, N 00° 13′ 35″ W for a distance of 450.00 feet to a 5/8″ re-rod w/cap (found);

Thence, N 86° 17′ 02″ W for a distance of 174.53 feet to a 5/8″ re-rod w/cap (found) on the left bank of the St. Marys River;

Thence, along said left bank on a non-tangent curve which is concave to the southwest, said curve having a central angle which measures 57° 15′ 35″, a radius which measures 125.08 feet, a chord which bears N 38° 42′ 57″ W and a chord which measures 119.87 feet, for a total arc length of 125.01 feet to a 5/8″ re-rod w/cap (set);

Thence, continuing along the aforesaid left bank on a non-tangent curve to the right, said curve having a central angle which measures 70° 11′ 02″, a radius which measures 128.61 feet, a chord which bears N 27° 45′ 57″ W, a chord which measures 147.88 feet, for a total arc length of 157.54 feet to a 5/8″ re-rod w/cap (set) on the north line of Section 32 (south line of Section 29);

Thence continuing along the aforesaid left bank with the following courses:

N 44° 19' 05" W for a distance of 131.73 feet to a point;

N 47º 12' 28" W for a distance of 109.43 feet to a point;

N 11° 01′ 38" W for a distance of 106.81 feet to a point;

N 13° 14' 28" W for a distance of 66.65 feet to a point;

N 04º 19' 17" W for a distance of 140.32 feet to a point;

N 46° 22′ 34″ E for a distance of 116.97 feet to a point;

S 74° 55′ 46″ E for a distance of 93.31 feet to a point; S 03° 10′ 15″ E for a distance of 195.22 feet to a point;

S 18° 41′ 35″ E for a distance of 94.75 feet to a point;

S 48° 50′ 53″ E for a distance of 93.30 feet to a 5/8″ re-rod w/cap (set) on the west line of the east half of the southwest quarter of Section 29;

Thence, continuing along the left bank of the St. Marys River, N 72° 05′ 05″ E for a distance of 258.05 feet to a 5/8″ re-rod c/cap (set);

Thence, along the aforesaid left bank on a non-tangent curve to the right, said curve having a central angle which measures 37° 22′ 42″, a radius which measures 173.60 feet, a chord which bears S 74° 59′ 31″ E, a chord which measures 111.25 feet for a total arc length of 113.25 feet to a 5/8″ re-rod w/cap (set);

Thence, continuing along the aforesaid left bank on a non-tangent curve to the left, said curve having a central angle which measures 73° 02′ 34″, a radius which measures 237.31 feet, a chord which bears N 70° 01′ 35″ E, and a chord which measures 282.45 feet for a total arc length of 302.53 to a 5/8″ re-rod w/cap (set);

Thence, leaving said left bank, N 89° 31′ 47″ E for a distance of 703.48 feet to a 5/8″ re-rod w/cap (set) on the east line of the east half of the southwest quarter of Section 29;

Thence, S 00° 18′ 02″ E along the aforesaid east line (passing through an iron bar found at the south quarter post of Section 29 and the north quarter post of Section 32 at a distance of 330.00 feet) for a total distance of 790.01 feet to a 5/8″ re-rod w/cap (set);

Thence, N 82° 53′ 37″ W for a distance of 557.79 feet to a 5/8″ re-rod w/cap (set);

Thence, S 73° 35′ 02″ W for a distance of 170.32 feet to a 5/8″ re-rod w/cap (set);

Thence, S 01° 45′ 24″ W (passing through a 5/8″ re-rod w/cap set on the north right-of-way line of Hesse Road at a distance of 261.62 feet) for a total distance of 281.63 feet to a mag-nail (set) on the centerline of Hesse Road;

Thence, N 86° 08′ 14″ W along the aforesaid centerline for a distance of 349.12 feet to the **POINT OF BEGINNING**, containing therein **24.929 acres** of which 10.920 acres is in Section 29 and 14.009 acres is in Section 32 and 0.160 acres is road right-of-way. Being a part of the east half of the northwest quarter of Section 32, Town-4-South, Range-4-East, Salem Township, Auglaize County, Ohio as evidenced by Official Record Volume 127, page 1 and more particularly described as follows:

Commencing for reference at an iron bar (found) at the north quarter post of Section 32; thence, S 00° 18′ 02″ E along the east line of the northwest quarter of Section 32 for a distance of 769.75 feet to a mag-nail (set), said mag-nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid line S 00° 18′ 02″ E (passing through the south right-of-way line of Hesse Road at a distance of 20.04 feet) for a total distance of 1891.78 feet to a stone found at the center of Section 32;

thence, S 89° 35′ 44" W along the south line of the northwest quarter of Section 32 for a distance of 1325.98 feet to a 5/8" re-rod w/cap (found) at the southwest corner of the east half of the northwest quarter;

thence, N 00° 14′ 05" W along the west line of the aforesaid east half (passing through the south right-of-way line of Hesse Road at a distance of 1981.51 feet) for a total distance of 2001.81 feet to a railroad spike (found) on the centerline of Hesse Road;

thence, along the centerline of Hesse Road on a non-tangent curve which is concave to the north, said curve having a central angle which measures 05° 45' 49", a radius which measures 2224.59 feet, a chord which bears S 83° 15' 20"E and a chord which measures 223.68 feet, for a total arc length of 223.78 feet to a railroad spike (found) at a point of tangency;

thence, continuing along the centerline of Hesse Road, S 86° 08' 14" E for a distance of 1104.59 feet to the **POINT OF BEGINNING**, containing therein **59.059** acres of which 0.610 acres is road right-of-way.
