



# Surveyor's Description

(can be used after proposed Indiana Avenue partial street vacation is approved)

The following described parcel of land is a part of the North Addition to the City of St. Marys as referenced by the original Plat of said North Addition as recorded in Plat Book 1, page 80, Plat Book 1A, Page 60, and Plat Book 1B, page 60. Reference is also made to an April, 1892 Common Pleas Court case #5278, specifically Exhibit A of the corresponding judgement journal, whereas a re-plat of all that part of the North Addition laying North of Indiana Avenue is recorded in Plat Book 1A, pages 376-378, Auglaize County Recorder's Office. The basis of the re-plat being referenced to a June, 1889 survey performed by Samual Craig. All such references being situated in the Southwest Quarter of Section 3, St. Marys Township, Town-6-South, Range-4-East, Auglaize County, Ohio, and is more particularly described as follows:

### Parcel #1

All of Lot Eighty (80) and Eighty-One (81) of the North Addition to the City of St. Marys, Ohio, save and except 20 feet off of the entire South side of Lot Eighty-One (81), being further described as follows:

Commencing at an Iron Pin (set) at the Northwest corner of Lot 80 of the North Addition to the City of St. Marys, Ohio and the PLACE OF BEGINNING;

Thence with an assumed bearing of N. 90°-00'-00" E. along the former Southerly right-of-way line of Indiana Avenue, being the Northerly line of Lot 80, for a distance of 110.59 feet to an Iron Pin (set);

Thence with a bearing of S. 25°-17'-03" E. along the Easterly line of Lot 80, for a distance of 51.14 feet to a Point situated at the Southeast corner of Lot 80;

Said "Public Landing" was vacated in proportionate widths such that the property lines of the adjacent owners of the North Addition containing Lots 80 to 85 were extended from the East line of said North Addition thence Easterly to the water's edge of the St. Marys River where applicable.

The proportionate lands of vacated property distributed to the combination of Permanent Parcels #K32-002-100-00 (all of Lot 80), and to Permanent Parcel K32-002-101-00 (16 feet off of the North side of Lot 81) is more particularly described as follows:

Commencing for reference at an Iron Pin (set) at the Northwest corner of Lot 80 of the North Addition to the City of St. Marys, Ohio, and the PLACE OF BEGINNING;

Thence with a bearing of N. 25°-17'-03" W. along the extension of the Easterly right-of-way line of Front Street, and the extension of the Westerly line of said Lot 80, for a distance of 8.85 feet to an Iron Pin (set);

Thence with a bearing of N. 90°-00'-00" E. parallel to and 8.00 feet North of the former Southerly right-of-way line of Indiana Avenue, for a distance of 98.67 feet to an Iron Pin (set);





### **Electric Utility Easement:**

The following described parcel of land is a part of the North Addition to the City of St. Marys as referenced by the original Plat of said North Addition as recorded in Plat Book 1, page 80, Plat Book 1A, Page 60, and Plat Book 1B, page 60, and is based upon a previously described permanent easement right as reserved and stipulated in Ordinance #2141 of the City of St. Marys, dated March 27, 1967 as per subject (2) of said Ordinance which states:

"A twenty (20) foot utility strip whose centerline starts on the northerly line of North Street sixty-seven (67) feet east of Lot No. 85, and extends northerly to a point on the southerly line of Indiana Avenue, parallel to the easterly line of said lots."

As a result of the action by the City of St. Marys to partially vacate portions of Indiana Avenue lying East of Front Street that was apportioned to Juli A. Sprague and Lynette A. Klopfenstein that pertains to City Ordinance #\_\_\_\_\_\_, dated \_\_\_\_\_\_, said twenty (20) foot utility strip upon Permanent Parcels #K32-002-100-00 and #K32-002-101-00 shall be more accurately described as follows:

Commencing for reference at an Iron Pin (found) at the Northwest corner of Lot 80 of the North Addition to the City of St. Marys, Ohio;

Thence with a bearing of S. 25°-17'-03" E. along the Easterly right-of-way line of Front Street, also being the Westerly line of Lots 80 and 81, for a distance of 114.50 feet to an Iron Pin (found) at the Southwest Corner of Permanent Parcel #K32-002-101-00;
