

LEGAL DESCRIPTION TRACT I

BEING A PART OF PARCEL K3204602200, ALSO KNOWN AS PART OUTLOT 42, ALL OF PARCEL K3204602300, ALSO KNOWN AS PART OF LOT 1 OF CHARLES ENGEL'S SUBDIVISON AS SHOWN ON PLAT BOOK 2, PAGE 10, ALL OF PARCEL K3204602400 ALSO KNOWN AS PART LOT 2 OF SAID CHARLES ENGEL'S SUBDIVISION AND PART OUTLOT 41 AND ALL OF PARCEL K3204602500 ALSO KNOWN AS PART LOT 2 OF SAID CHARLES ENGEL'S SUBDIVISION AND PART OUTLOT 41 AND BEING OWNED BY THE CITY OF ST. MARYS AS DESCRIBED IN OFFICIAL RECORD 710, PAGE 2314 OF THE AUGLAIZE COUNTY DEED RECORDS, SITUATE IN THE SOUTHWEST QUARTER OF SECTION 3, TOWN 6 SOUTH, RANGE 4 EAST, CITY OF ST. MARYS, AUGLAIZE COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Commencing for reference at the intersection of the south right-of-way line of Spring Street and the east right-of-way line of Front Street;

thence, North 65°-35'-59" East, 289.36 feet, along the south right-of-way line of Spring Street to a cut cross set on the northeast corner of a tract of land owned by Friends of the Saint Marys Theater as described in Official Record 712, Page 5360 and being the principal place of beginning of the tract herein described;

thence, North 65°35'59" East, 1.52 feet, along the south right-of-way line of Spring Street to a point;

thence, North 54°-58'-26" East, 39.57 feet, along the south right-of-way line of Spring Street to a cut cross set;

thence, North 36°-02'-29" East, 81.15 feet, along the south right-of-way line of Spring Street to cut cross set:

thence, South 85°-39'-50" East, 111.21 feet, to a point on the west line of a tract of land owned by the City of St. Marys as described in Deed Book 130, Page 369;

thence, South 14°-19'-49" West, 149.48 feet, to a Mag Nail set, passing for reference a Mag nail set at 60.00 feet;

thence, South 53°-34'-40" East, 0.69 feet, to a point;

thence, South 65°-51'-23" West, 20.77 feet, along the face of an existing building to a point on the north line of a tract of land owned by the City of St. Marys as described in Deed Book 207, Page 390;

thence, South 31°-06'-24" West, 30.26 feet, to an iron pipe found on the north line of said City of St. Marys tract;

thence, North 35°-39'-02" West, 17.60 feet, to a point on the face of an existing building and being on the north line of said City of St. Marys tract;

thence, South 65°-57'-41" West, 47.27 feet, along the north line of said City of St. Marys tract to a point on the north line of a tract of land owned by the City of St. Marys as described in Deed Book 186, Page 21;

thence, North 87°-42'-46" West, 22.66 feet, to a Mag nail set;

thence, North 23°-48'-08" West, 0.63 feet, to a point;

thence, North 65°-29'-44" East, 1.35 feet, to a point;

thence, North 24°-24'-33" West, 112.03 feet, along the line between 2 buildings to the principal place of beginning.

MARYS, AUGLAIZE COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Commencing for reference at the intersection of the south right-of-way line of Spring Street and the east right-of-way line of Front Street;

thence, North 65°-35'-59" East, 289.36 feet, along the south right-of-way line of Spring Street to a cut cross set on the northeast corner of a tract of land owned by Friends of the Saint Marys Theater as described in Official Record 712, Page 5360;

thence, South 24°24'33" East, 100.42 feet, along the line between two buildings and the east line of said Friends of Saint Marys Theater tract to the principal place of beginning;

thence, South 24°-24'-33" East, 11.61 feet, along a new division line to a point on the north line of a tract of land owned the City of St. Marys as described in 186, Page 21;

thence, South 65°-29'-44" West, 1.35 feet, along the north line of said City of St. Marys tract to a point on the east line of said Friends of the Saint Marys Theater tract;

thence, North 23°-48'-08" West, 11.61 feet, along the east line of said Friends of the Saint Marys Theater tract to a point;

thence, North 65°-39'-29" East, 1.22 feet, along the face of an existing building to the principal place of beginning of the tract herein described.
