SITUATE IN THOSE LANDS PLATTED AS MILL STREET & LOT 1, BLOCK 38 IN THE PLAT BOOK 2 PAGE 68, OF EAST ADDITION OF THE CITY OF ST. MARYS IN THE SOUTH WEST QUARTER OF SECTION 3 TOWN 6 SOUTH, RANGE 4 EAST, CITY OF ST. MARYS AND BEING ST. MARYS TOWNSHIP, AUGLAIZE COUNTY OHIO, AND BEING ALL OF THOSE LANDS OWNED BY BLACK DOG HOLDINGS, LLC AS RECORDED IN OFFICIAL RECORD 716 PAGE 3743 AND BEING MORE PARTICULLARY DESCRIBED AS FOLLOWS:

Beginning for reference at the southeast corner of Lot 10, Block 33 of the East Addition of the City of St. Marys and the intersection of the west line of Chestnut Street and the north line of Spring Street;

Thence, with the north line of Spring Street, the south line of Block 33 and the south line of Lot 1, Block 38, South 65°25'02" West, 182.97 feet to the **True Point of Beginning** of the tract of land herein described, witnessing at South 24°26'02" East, 5.00 feet a Mag Nail set;

Thence, continuing with the north line of Spring Street and the south line of said Lot 1, South 65°25'02" West, 20.50 feet, witnessing at South 24°26'02" East, 5.00 feet a Mag Nail set;

Thence, with the east line of a 0.109 acre tract of land owned by First Financial Bank, N.A. as recorded in Official Record 573 Page 1661, North 24°26'02" West, 81.00 feet to an iron pin set;

Thence, with the lands owned by the State of Ohio, North 65°29'02" East, 20.50 feet to an iron pin set;

Thence, South 24°26'02" East, 81.00 feet to the **True Point of Beginning**, containing 0.038 acres more or less and being subject to all legal rights of way, easements, agreements and restrictions of record.

Basis of bearings is based on the Ohio Department of Transportation V.R.S., Ohio State Plane North Zone 3401, NAD 83(2011ADJ). The Official Records and Deed Volumes are all recorded in Auglaize County Recorder's Office. Pins noted as set are 5/8" x 30" re-bar with pink plastic caps stamped "Lock-Two 7988".
