Surveyor's Description of a proposed street right-of-way vacation of Weston Street in the City of St. Marys containing 0.039 Acres (1,706.092 square feet)

The following described parcel of land is a part of Lot 1 of the J. & D.A. Barrington Subdivision (see Plat Book 1B, Page 252) of Outlot 61 to the City of St. Marys, and being situated in the Southeast Quarter of Section 3, St. Marys Township, Town-6-South, Range-4-East, Auglaize County, Ohio;

Commencing for reference at a PK Nail (found) situated at the centerline intersection of Beech Street and Weston Street in the City of St. Marys, Ohio;

Thence with a bearing of S. 89°-18'-17" W. along the centerline of Weston Street for a distance of 343.07 feet to a Mag Nail (found) at the centerline intersection of said Weston Street with Vine Street;

Thence with a bearing of N. 00°-42'-43" W. along the centerline of Vine Street for a distance of 44.28 feet to a Mag Nail (found);

Thence with a bearing of S. 89°-38'-58" W. for a distance of 33.00 feet to an Iron Pin (found) being situated at the intersection of the Westerly right-of-way line of Vine Street and the Northerly right-of-way line of Weston Street;

Thence continuing with a bearing of S. 89°-38'-58" W. along the Northerly right-of-way line of Weston Street for a distance of 112.57 feet to an Iron Pin (found);

Thence with a bearing of N. 81°-51'-56" W. along the Northerly right-of-way line of Weston Street for a distance of 25.01 feet to an Iron Pin (found);

Thence continuing with a bearing of N. 81°-51'-56" W. for a distance of 19.79 feet to an Iron Pin (set) and the PLACE OF BEGINNING;

Thence continuing with a bearing of N. 81°-51'-56" W. for a distance of 158.53 feet to an Iron Pin (set) at the Southwest corner of Permanent Parcel #K32-015-183-00 as referenced by Deed Volume OR 720, Page 2379;

Thence with a bearing of N. 89°-38'-58" E. for a distance of 145.88 feet to an Iron Pin (set) at the Southeast corner of said Permanent Parcel #K32-015-183-00;

Thence with a bearing of S. 25°-21'-40" E. along the Westerly line of a 16.50 foot public alley for a distance of 25.81 feet to an Iron Pin (set) and the original PLACE OF BEGINNING.

Containing in all, 0.039 Acres of land (1,706.092 square feet). The above described tract of land is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

The basis of bearings used for this description were determined from a prior survey by Mike Weadock for the City of St. Marys as recorded in Survey Book G, Page 426, Auglaize County Engineer's Map Office, and also being recorded as Survey H-446, City of St. Marys Engineering Department, whereas the centerline of Vine Street in Blocks 18 and 19 of said J. & D.A. Barrington Subdivision of Outlot 61 to the City of St. Marys bears N. 25°-21'-10" W.
