The following described parcel of land contains a part of Block 40 of the East Addition, all of Outlot 56, and part of Outlot 57 to the City of St. Marys, and is situated in the Southeast Quarter of Section 3, St. Marys Township, Town-6-South, Range-4-East, Auglaize County, Ohio, and is a split out of a property formerly known as the State of Ohio Armory, and is referenced by Volume OR 723, Page 0001, City of St. Marys, Ohio, said parcel split being further described as follows:

Commencing for reference at a Mag Nail (found and being located according to City of St. Marys street intersection reference book, page #207) and also being situated at the centerline intersection of Chestnut Street and South Street in said City of St. Marys, Ohio;

Thence with a bearing of S. 24°-06'-13" E. along a line being the extension of said centerline of Chestnut Street for a distance of 33.00 feet to a scribed cross ("x") sawed in a concrete walk (found) located on the Southerly right-of-way line of South Street and the PLACE OF BEGINNING;

Thence with a bearing of N. 65°-38'-39" E. along the Southerly line of South Street, for a distance of 80.00 feet to a Mag Nail (set), and passing through a point for reference being situated at the Northwest corner of Block 40 of the East Addition to the City of St. Marys at a distance of 33.00 feet;

Thence with a bearing of N. 65°-31'-30" E. along the Southerly line of South Street, for a distance of 245.54 feet to a scribed cross ("x") sawed in a concrete walk (found) and the original PLACE OF BEGINNING.


