





DESCRIPTION OF 0.329 ACRE TRACT

Beginning at a #5 rebar set at the southeast corner of said Lot Number 7, also being on the west right of way line of Jack Oak Point (60' R/W);

Thence along the south line of said Lot No. 7, North 84°-32'-10" West, a distance of 114.76 feet to a #5 rebar set for the southwest corner of said Lot No. 7;

Thence along the west line of said Lot Numbers 6 & 7 and Part Lot Number 5, North 05°-00'-00" East, a distance of 125.00 feet to a #5 rebar set;

Thence along a new division line, South 84°-32'-10" East, a distance of 114.76 feet to a #5 rebar set on the west right of way line of said Road;

Thence along the west right of way line of said Road, South 05°-00'-00" West, a distance of 125.00 feet to the place of beginning. Containing 0.329 acres.
