



AN 18.5' X 60' PARCEL IS NOT INCLUDED IN THE DEED TO CHARLES NELSON @ O.R. VOL. 155 PG. 524. IT IS SHOWN ON THE TAX MAP AS BEING OWNED BY NELSON. LEGAL ADVICE IS RECOMMENDED. THERE IS AN EASEMENT TO THE CITY ALONG THIS STRIP AND CONTINUING SOUTH FOR MAINTENECE OF A SANITARY SEWER. TERE IS ALSO AN APPARENT EASEMENT OVER THIS STRIP AND CONTINUING SOUTH FOR OVERHEAD UTILITIES. FURTHER RESEARCH WAS NOT WARRANTED.

Thence, South 00°01'03" East, along the west line of Lots 47 and 48 in Howell's Subdivision of the South Part of Out Lot Number 92, a distance of 57.52 feet to a point -

Thence, South 89°47'46" West, a distance of 148.34 feet to a point -

Thence, North 00°01'58" East, along the east line of Wayne Street, a distance of 175.87 feet to a cotton gin spindle -

Thence, North 38°11'04" East, a distance of 43.59 feet to a 5/8 inch iron bar -

Thence, North 89°47'46" East, a distance of 121.23 feet to 5/8 inch iron bar -

Thence, North 00°01'03" West, a distance of 10.97 feet to a 5/8 inch iron bar -

Thence, North 89°47'46" East, a distance of 155.00 feet to a 5/8 inch iron bar -

Thence, South 00°01'03" East, a distance of 164.10 feet to a 5/8 inch iron bar -

Thence, North 89°58'33" West, a distance of 155.00 feet to the place of beginning.
