

Beginning for reference at the northwest corner of the northwest quarter of Section 15;

Thence, with the north line of the northwest quarter of Section 7 and the south line of a 6.750 acre tract of land owned by J & M Wendeln (Trustees) as recorded in Official Record 258 Page 358, South 88°45'47" East, 1383.35 feet to an iron pin set said iron pin marking the True Point of Beginning of the tract herein described;

Thence, with the south line of a 1.650 acre tract of land owned by Dayton Power & Light as recorded in Deed Volume 195 Page 410, South 88°45'47" East, 679.31 feet to a 1 inch iron pin in a monument box found in the center line of County Road 66-A, passing for reference at 649.31 feet the west right of way line of County Road 66-A:

Thence, with the center line of County Road 66-A, South 10°33'43" East, 1955.42 feet to a Mag Spike set over a P.K. Nail found at the P.T. of a curve;

Thence, with the center line of County Road 66-A with a curve to the right having a Delta Angle of 16°57'17", Radius of 1622.33 feet, Arc Length 480.07 feet with a Long Chord bearing South 01°10'32" East, 478.32 feet to a Mag Spike set over a P.K. nail found at the P.C. of said curve;

Thence, with the center line of County Road 66-A, South 08°39'44" West, 259.94 feet to a 1 inch iron pin in a monument box found:

Thence, with the south line of the northwest quarter of Section 15 and the north line of a 54.135 acre tract of land owned by Minster Capital LLC as recorded in Official Record 473 Page 324, North 88°55'06" West, 1063.39 feet to an iron pin set, passing for reference at 30.00 feet the west right of way line of County Road 66-A;

Thence, with the east line of the Western Ohio Rail Authority as recorded in Official Record 1306 Page 698, North 01°11'14" East, 2652.63 feet to the True Point of Beginning containing 57.085 acres more of less with 1.856 acres lying in the right of way of County Road 66-A and being subject to all legal rights of way, easements, agreements and restrictions of record.
