
OTTERBEIN HOMES SURVEY

OTTERBEIN HOMES SURVEY DESCRIPTION

Being a parcel of land situated in St. Marys Township, Auglaize County, Ohio, in Section 17, Township 6 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at a 5/8 inch iron bar at the southwest corner of said Section 17-

Thence, south 89°00'41" east, along the south line of the southwest quarter of said Section 17, a distance of one thousand three hundred twenty-three and 82/100 (1323.82) feet to a 5/8 inch iron bar. Said point being the place of beginning for the herein described parcel of land-

Thence, continuing, south 89°00'41" east, along the last described line, a distance of one hundred twenty-four and 95/100 (124.95) feet to a concrete monument-

Thence, north 50°26'32" east, along said centerline of State Route 364, a distance of six hundred eighty-eight and 39/100 (688.39) feet to a "P.K." nail at the "P.C." of a curve to the left having a radius of 1041.74 feet and a delta angle of 17°23'27"-

Thence, northeasterly along said curve in the centerline of State Route 364, an arc distance of three hundred sixteen and 20/100 (316.20) feet to a "P.K." nail at the "P.T.' of said curve. The chord to the last described call bears north 41°44'47" east, 314.98 feet-

Thence, continuing, along the centerline of State Route 364, north 33°03'05" east, a distance of seven hundred sixty-two and 91/100 (762.91) feet to a "P.K." nail-

Thence, continuing, along the centerline of State Route 364, north 33°19'14" east, a distance of three and 91/100 (3.91) feet to a point in the south line of the northeast quarter of the southwest quarter of Section 17-

Thence, south 88°58'20" east, along said south line of the northeast quarter of the southwest quarter of Section 17, a distance of sixty-six and 12/100 (66.12) feet to a 5/8 inch iron bar at the southeast corner thereof-

Thence, north 01°07'14" east, along the east line of the southwest quarter of said Section 17, a distance of one hundred four and 90/100 (104.90) feet to a point in the centerline of the afore mentioned State Route 364-

Thence, north 33°19'14" east, along said centerline of State Route 364, a distance of three hundred twenty-seven and 55/100 (327.55) feet to a railroad spike-

Thence, continuing, along the centerline of State Route 364, north $16^{\circ}56'47''$ east, a distance of two hundred twenty and 68/100(220.68) feet to a point-

Thence, north $81^{\circ}00'15''$ west, a distance of one hundred twenty-two and 96/100(122.96) feet to an iron pipe set in concrete-

Thence, north 81°00'15" west, a distance of one hundred seventy-four and 76/100 (174.76) feet to an iron bar set in concrete-

Thence, north 03°08'41" west, a distance of thirty and 62/100 (30.62) feet to the waters edge of Young's Channel-

Thence, northeasterly, along the waters edge of Young's Channel, the following courses and distances:

north 19°20'38" east, 23.91 feet to a point-

north 33°09'45" east, 39.03 feet to a point-

north 02°14'54" east, 85.07 feet to a point-

north 36°17'52" east, 27.27 feet to a point-

north 52°26'54" east, 79.36 feet to a point-

Thence, south 88°55'58" east, along said east-west half section line, a distance of seventy-eight and 06/100 (78.06) feet to a "P.K." nail in the afore mentioned centerline of State Route 364-

Thence, north 16°56'47" east, along said centerline of State Route 364, a distance of four hundred thirteen and 07/100 (413.07) feet to a "P.K." nail-
