SURVEYOR'S DESCRIPTION

Being a part of the southeast quarter of Section 17, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio as evidenced by Official Record Volume 44, Page 859 and more particularly described as follows:

Commencing for reference at a harrow tooth (found) at the intersection of the centerline of State Route 364 and the north line of the southeast quarter of Section 17; thence, S 16° 56' 47" W along the centerline of State Route 364 for a distance of 475.01 feet to a p-k nail (found), said nail being the **POINT OF BEGINNING** for the tract herein described;

Thence, continuing along the aforesaid centerline, S 16° 56' 47" W for a distance of 80.07 feet to a mag-nail (set);

Thence, N 76° 03' 33" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of State Route 364 at a distance of 30.04 feet) for a total distance of 133.98 feet to a 5/8" re-rod w/cap (set);

Thence, N 37° 29' 17" W (passing through a 5/8" re-rod w/cap set for reference at a distance of 80.34 feet) for a total distance of 97.05 feet to a point in Young's Channel to Grand Lake;

Thence, running with said channel along the following courses, N 64° 00' 18" E for a distance of 43.86 feet to a point; N 86° 05' 56" E for a distance of 45.53 feet to a point:

Thence, leaving said channel S 66° 40' 28" E (passing through a 5/8" re-rod w/cap found at a distance of 13.41 feet, and a 5/8" re-rod w/cap found on the west right-of-way line of State Route 364 at a distance of 108.76 feet) for a total distance of 138.95 feet to the **POINT OF BEGINNING**, containing therein **0.383** acres of which 0.057 acres are road right-of-way.

Commencing for reference at a harrow tooth (found) at the intersection of the centerline of State Route 364 and the north line of the southeast quarter of Section 17; thence, S 16° 56′ 47″ W along the centerline of State Route 364 for a distance of 555.08 feet to a mag nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid centerline, S 16° 56' 47" W for a distance of 135.99 feet to a mag-nail (set);

thence, N 81° 07' 41" W (passing through a 5/8" re-rod w/cap set on the west right-of-way line of State Route 364 at a distance of 30.30 feet) for a total distance of 164.73 feet to a 5/8" re-rod w/cap (set);

Commencing for reference at a harrow tooth (found) at the intersection of the centerline of State Route 364 and the north line of the southeast quarter of Section 17; thence, S 16° 56' 47" W along the centerline of State Route 364 for a distance of 691.07 feet to a mag nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid centerline, S 16° 56' 47" W for a distance of 80.07' feet to a p-k-nail (found);

thence, N 81° 00′ 15″ W (passing through a 5/8″ re-rod w/cap found on the west right-of-way line of State Route 364 at a distance of 30.29 feet) for a total distance of 297.72 feet to an iron pipe in concrete (found);
