RESOLUTION

WHEREAS, a petition was filed with the Clerk of the Board of County Commissioners by Attorney Barry Kemp on June 13, 2001, for Steven R. Klosterman, President of Klosterman Development Corporation, regarding the vacation of the following described roadway located in Klosterman Kove Subdivision in St. Marys Township:

Being a part Klosterman Kove Subdivision, Phase 1 of the southwest quarter of the southeast quarter of Section 18, Town-6-South, Range-4-East, St. Marys Township, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a 5/8" re-rod w/cap (found) at the northwest corner of Lot 4 of said Klosterman Kove, Phase 1, said point also being on the easterly right-of-way line of Willie's Way; thence, along the westerly line of Lot 4 and the easterly right-of-way line of Willie's Way along a curve which is concave to the northeast, having a radius of 75.00 feet, a central angle which measures 01 degree 31' 28", a chord which bears S 19 degrees 30' 06" E, a chord which measures 2.00 feet, for a total arc length of 2.00 feet to a 5/8" re-rod w/cap (found); thence, continuing along the aforesaid westerly line and easterly right-of-way line, S 20 degrees 15' 49" E for a distance of 48.92 feet to a 5/8" re-rod w/a cap (set), said re-rod being the POINT OF BEGINNING for the tract herein described;

thence, continuing along the aforesaid westerly line and easterly right-of-way line, S 20 degrees 15' 49" E for a distance of 9.69 feet to a 5/8" re-rod w/cap (found);

thence, along a curve to the left, having a radius of 50.00 feet, a central angle which measures 68 degrees 46' 26", a chord which bears S 54 degrees 39' 02" E, a chord which measures 56.48 feet, for a total arc length of 60.02 feet to a 5/8" re-rod w/cap (found);

thence, \$ 00 degrees 57' 40" W for a distance of 50.00 feet to a 5/8" re-rod w/cap (found);

thence, N 89 degrees 02' 14" W for a distance of 35.90 feet to a 5/8" re-rod w/cap (found);

thence, N 32 degrees 43' 02" W for a distance of 1.51 feet to a 5/8" re-rod w/cap (set);

thence, along a curve to the right, having a radius of 40.00 feet, a central angle which measures 33 degrees 53' 54", a chord which bears N 15 degrees 46' 05" W, a chord which measures 23.32 feet, for a total arc length of 23.67 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 10' 52" E for a distance of 30.70 feet to a 5/8" re-rod w/cap (set);

thence, along a curve to the left, having a radius of 100.00 feet, a central angle which measures 21 degrees 26' 41", a chord which bears N 09 degrees 32' 29" W, a chord which measures 37.21 feet, for a total arc length of 37.43 feet to the POINT OF BEGINNING, containing therein 2,453 square feet or 0.056 acres.

WHEREAS, in accordance with the Ohio Revised Code, Section 5553.23, 5553.042 and 5553.04 through 5553.11, the Board of County Commissioners does accept the petition for the vacation as stated above and sets the date of view in connection with same for July 12, 2001 at 1:30 p.m., meeting at the site of proposed vacation; setting date of hearing for July 19, 2001 at 2:00 p.m. to be held in the office of the Auglaize County Commissioners, Courthouse Basement, Wapakoneta, OH.
