
MANBECK & SONS, INC. SURVEY

Thence, South 89°55'45" West, along the north line of the northwest quarter of said Section 36 and the centerline of Southland Road, a distance of 859.34 feet to a spindle. Said point being the place of beginning for the parcel of land to be conveyed by this instrument -

Thence, continuing, South 89°55'45" West, along the last described line, a distance of 618.53 feet to a point in the approximate centerline of an open ditch. Said point being marked by a Mag nail in the pavement above -

Thence, North 00°10'13" East, a distance of 119.82 feet to the place of beginning.
