## SURVEYOR'S DESCRIPTION Tract "A-1"

Being a part of the northwest quarter of Section 1, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northwest quarter of Section 1, and the centerline of Graham Road; thence, N 00° 30′ 00″ W along the west line of the northwest quarter and the legal centerline of Graham Road, for a distance of 154.00 feet to a railroad spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid west line and legal centerline N 00° 30' 00" W for a distance of 412.72 feet to a p-k nail (found);

thence, N 89° 35' 00" E (passing through a 5/8" re-rod w/cap found on the east right-of-way line of Graham Road at a distance of 23.00 feet) for a total distance of 437.32 feet to a 5/8" re-rod w/cap (set);

\* thence, S 00° 21' 15"  $\boldsymbol{E}$  for a distance of 379.94 feet to a 5/8" re-rod w/cap (set);

thence, S 89° 38' 45" W for a distance of 151.92 feet to a 5/8" re-rod w/cap (found);

thence, S 82° 58′ 30″ W (passing through a 5/8″ re-rod w/cap set on the east right-of-way line of Graham Road at a distance of 263.11 feet) for a total distance of 286.26 feet to the **POINT OF BEGINNING** containing therein **3.916 acres**, of which 0.217 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per the "Phipps Survey" prepared by Ted Kevin Schnell, PS 7216 on February 14, 1994 depicting the west line of the northwest quarter of Section 1 as bearing N 00° 30′ 00″ W. ## SURVEYOR'S DESCRIPTION Tract "A-2"

Being a part of the northwest quarter of Section 1, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio and more particularly described as follows:

Commencing for reference at a monument box (found) at the southwest corner of the northwest quarter of Section 1, and the centerline of Graham Road; thence, N 89° 38' 45" E along the south line of the northwest quarter of Section 1 for a distance of 291.54 feet to a 5/8" re-rod (found), said re-rod being the **POINT OF BEGINNING** for the tract herein described;

thence, N 02° 41' 00" W for a distance of 187.51 feet to a 5/8" re-rod (found);

\* thence, N 89° 38' 45" E for a distance of 151.92 feet to a 5/8" re-rod w/cap (set);

thence, N 00° 21' 15" W for a distance of 379.94 feet to a 5/8" re-rod w/cap (set);

thence, N 89° 35' 00" E for a distance of 20.00 feet to a 5/8" re-rod w/cap (found);

thence, S 35° 12' 00" E for a distance of 691.27 feet to a 5/8" re-rod (found) on the south line of the northwest quarter of Section 1;

thence, S 89° 38′ 45″ W along the south line of the northwest quarter of Section 1 for a distance of 559.27 feet to the **POINT OF BEGINNING** containing therein **3.470 acres**. The subject tract is an "add-on" tract, and is not meant to be a separate residence lot. Subject to all easements and right-of-way of record at the time of the recording of this instrument.
