

## SURVEYOR'S DESCRIPTION



scale:

Being a part of the northeast and northwest quarter of Section 13, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio as evidenced by Official Record Volume 127, Page 471 and combining Parcel No. L3401300808 and L340100700 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northeast corner of the northeast quarter of Section 13 and the centerline intersection of Fairmount Road with Santa Fe Line Road; thence, S 00° 47′ 33″ W along the east line of the northeast quarter of Section 13 and the legal centerline of Santa Fe Line Road for a distance of 570.00 feet to a railroad spike (found), said spike being the POINT OF BEGINNING for the tract herein described;

Thence, continuing S 00° 47' 33" W along the aforesaid east line and centerline for a distance of 745.63 feet to a railroad spike (found);

Thence, N 89º 12' 27" W (passing through a 5/8" re-rod w/cap found on the west right-of-way line of Santa Fe Line Road at a distance of 20.00 feet) for a total distance of 362.00 feet to a 3/8" re-rod (found);

Thence, N 00º 47' 33" E for a distance of 369.00 feet to a 3/8" re-rod (found);

Thence, N 89º 12' 27" W for a distance of 520.00 feet to a 3/8" re-rod (found);

Thence, S 00º 47' 33" W for a distance of 419.00 feet to a 3/8" re-rod (found);

Thence, S 89º 12' 27" E for a distance of 520.00 feet to a 5/8" re-rod (found);

Thence, S 00º 47' 33" W for a distance of 964.00 feet to a 5/8" re-rod (found);

Thence, S 89º 12' 27" E (passing through a 5/8" re-rod found on the west right-of-way line of Santa Fe Line Road at a distance of 342.00 feet) for a total distance of 362.00 feet to a railroad spike (found) on the legal centerline of Santa Fe Line Road and the east line of the northeast quarter of Section 13;

Thence, S 00º 47' 33" W along the aforesaid centerline and east line for a distance of 314.74 feet to a monument box (sound) at the east quarter corner of Section 13;

Thence, N 89º 13' 29" W along the south line of the northeast quarter of Section 13 for a distance of 2645.91 feet to the southwest corner of the northeast quarter of Section 13;

Thence, N 89º 13' 29" W along the south line of the northwest quarter of Section 13 for a distance of 362.79 feet to a 5/8" re-rod (found);

Thence, N 01º 56' 39" E for a distance of 1270.26 feet to a 5/8" re-rod (found);

Thence, N 89º 01' 12" E for a distance of 336.18 feet to a 5/8" re-rod (found);

Thence, N 00º 17' 46" E for a distance of 196.54 feet to a 5/8" re-rod (found);

Thence, N 13º 22' 05" W for a distance of 115.55 feet to a 5/8" re-rod (found);

Thence, S 88º 36' 57" E for a distance of 621.17 feet to a 5/8" re-rod (found);

Thence, N 00º 46' 51" E for a distance of 249.20 feet to a wooden end post (found);

Thence, N 89º 17' 49" W for a distance of 18.40 feet to a 5/8" re-rod (found);

Thence, N 00º 55' 46" E (passing through a 5/8" re-rod found on the south right-of-way Fairmount Road at a distance of 780.31 feet) for a total distance of 810.31 feet to a p-k nail (found) on the north line of the northeast quarter of Section 13 and the legal centerline of Fairmount Road;

Thence, S 89º 17' 49" E along the aforesaid north line and legal centerline for a distance of 1710.50 feet to a railroad spike (found);

Thence, S 00º 47' 33" W (passing through a 5/8" re-rod found on the south right-of-way line of Fairmount Road at a distance of 30.00 feet) for a total distance of 362.00 feet to a ¾" re-rod (found);

Thence, N 89º 17' 49" W for a distance of 56.86 feet to a 3/4" re-rod (found);

Thence, S 00º 47' 33" W for a distance of 208.00 feet to a 3/4" re-rod (found);

Thence, S 89º 17' 49" E (passing through a ¾" re-rod found on the west right-of-way line of Santa Fe Line Road at a distance of 398.86 feet) for a total distance of 418.86 feet to the POINT OF BEGINNING, containing therein 138.408 acres, of which 128.047 acres is in the northeast quarter and 10.361 acres is in the northwest quarter, and 1.664 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Basis of bearings is per Auglaize County GPS depicting the east line of the northeast quarter of Section 13 as S 00º 47' 33" W. Prepared by James M.
