

DESCRIPTION TRACT ONE

Being a part of the west half of the northwest quarter of Section 27, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio as evidenced by Official Record Volume 120, Pages 869, 874 and 879 and more particularly described as follows:

Commencing for reference at a monument box (found) at the southeast corner of the west half of the northwest quarter of Section 27 and the legal centerline of Boundry Road; thence, N 00 degrees 19' 47" E along the east line of the west half of the northwest quarter of Section 27 and the legal centerline of Boundry Road, for a distance of 1142.02 feet to a mag-nail (set) at the northeast corner of that parcel evidenced by Official Record Volume 309, Page 520, said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, N 88 degrees 41' 04" W and along the north line of the aforesaid parcel (passing through a 5/8" re-rod w/cap set on the west right-of-way line of Boundry Road at a distance of 25.00 feet) for a total distance of 544.08 feet to a 5/8" re-rod w/cap (found) at the northwest corner of the aforesaid parcel;
