Commencing for reference at a concrete monument (found) at the South ¼ Corner of Section 33 and the centerline of Kuenstle Road; thence, N 00º 57' 21" E along the east line of the southwest quarter of Section 33 and the centerline of Kuenstle Road for a distance of 1330.25 feet to a p-k nail (found) and the POINT OF BEGINNING for the tract herein described:

thence, N 89º 55' 33" W (passing through the west right-of-way line of Kuenstle Road at a distance of 20.00 feet and a 5/8" re-rod w/cap set for reference at a distance of 25.00 feet) for a total distance of 1321.67 feet to an 8" wood end post (found);
