
Kaufman ~ Little Boundary Survey



Being a part of the northeast quarter and northwest quarter of Section 34, Town-5-South, Range-7-East, Union Township, Auglaize County, Ohio as evidenced by Official Record Volume 448, Page 961 and more particularly described as follows:

Commencing for reference at a mag-nail (found) at the northwest corner of the east one-half of the northwest quarter of Section 34 and the centerline intersection of Boundary Road and Middle Pike; thence, S 89° 14′ 26″ E along the north line of the aforesaid east one-half and the centerline of Middle Pike for a distance of 785.06 feet to a mag-nail (set), said nail being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing along the aforesaid north line and centerline of Middle Pike, S 89° 14′ 26″ E for a distance of 345.95 feet to a monument box (found) at the north quarter corner of Section 34;

thence, along the north line of the northeast quarter of Section 34 and the centerline of Middle Pike, S 89° 16′ 37″ E for a distance of 1190.46 feet to a mag-nail (set);

ROBERT E. LITTLE SURVEY 3.669 ACRE TRACT

The following described tract of land is part of the Northwest Quarter of Section 34, Town 5 South, Range 7 East, Union Township, Auglaize County, Ohio, being Parcel No. L33-034-002-04 and is more particularly described as follows:

Commencing at a Monument Box (found) at the Northwest corner of the East ½ of the Northwest Quarter of Section 34, Union Township and in the intersection of the centerlines of Township Road 223 (Boundary Road) and County Road 150 (Middle Pike);

Thence S.89°14'26"E. along the North line of the Northwest Quarter of said Section 34, Union Township and along the legal centerline of County Road 150, a distance of 735.06 feet to a Mag Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described;

Thence continuing S.89°14'26"E. along the above described centerline, a distance of 50.00 feet to a Mag Nail (set);

Thence S.00°50'07"W. a distance of 1,323.23 feet to a 5/8-inch iron pin (set), passing thru a 5/8-inch iron pin set for reference at 25.00 feet in the South Right-of-way line of said County Road 150 (Middle Pike);

Thence N.88°19'40"W. a distance of 202.69 feet to a 4-inch diameter steel post (found); Thence N.06°22'00"W. a distance of 510.27 feet to a 5/8-inch iron pin (found);

Thence S.89°14'23"E. a distance of 216.64 feet to a 5/8-inch iron pin (found);
