LEGAL DESCRIPTION

TRACT THREE

A part of the West One-Half of the northwest quarter of Section 13, T-6-S, R-5-E, Washington Township, Auglaize County, Ohio as evidenced by Official Record Volume 85, Page 432, and being more particularly described as follows:

Commencing at a monument box (found) at the west quarter corner of Section 13 and the legal centerline of Burr Oak Road; thence, S 88 degrees 56' 21" E along the south line of the west one-half of the northwest quarter and the legal centerline of Burr Oak Road, for a distance of 1130.03 feet to a mine spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

thence, N 01 degree 03' 39" E (passing through a 5/8" re-rod found on the north right-of-way line of Burr Oak Road at a distance of 25.00 feet) for a total distance of 369.37 feet to a 5/8" re-rod w/cap (found);

thence, S 88 degrees 56' 21" E (parallel with the south line of the west one-half of the northwest quarter of Section 13) for a distance of 169.19 feet to a 5/8" rerod w/cap set 30.00 feet west of the east line of the west one-half of the northwest quarter of Section 13;

thence, N 01 degree 01' 54" E (30.00 feet west of and parallel with the east line of the west one-half of the northwest quarter of Section 13) for a distance of 1351.23 feet to a 5/8" re-rod w/cap (set);

A part of the West One-Half of the northwest quarter of Section 13, T-6-S, R-5-E, Washington Township, Auglaize County, Ohio as evidenced by Official Record Volume 85, Page 432, and being more particularly described as follows:

Commencing at a cotton gin spindle (set) at the southeast corner of the west one-half of the northwest quarter of Section 13, and the legal centerline of Burr Oak Road; thence, N 88 degrees 56' 21" W along the south line of the west one-half of the northwest quarter and the legal centerline of Burr Oak Road, for a distance of 484.38 feet to a mine spike (found), said spike being the POINT OF **BEGINNING** for the tract herein described:

thence, continuing N 88 degrees 56' 21" W along the aforesaid south line and legal centerline, for a distance of 845.03 feet to a monument box marking the location of the west quarter corner of Section 13;

thence, N 00 degrees 55' 36" E along the west line of the west one-half of the northwest quarter of Section 13, for a distance of 2035.69 feet to a 5/8" re-rod w/cap (set);
