LEGAL DESCRIPTION

Being a part of the southeast quarter of the northeast quarter of Section 18, T-6-S, R-5-E, Washington Township, Auglaize County, Ohio as evidenced by OR Volume 19, Page 470 and more particularly described as follows:

Commencing at a monument box (found) at the southeast corner of the northeast quarter of Section 18 and the legal centerline of Glynwood-New Knoxville Road; thence, N 01 degree 23' 34"E along the east line of the northeast quarter of said Section 18 and the legal centerline of Glynwood-New Knoxville Road, for a distance of 954.22 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, N 89 degrees 33' 06" W (passing through a 5/8" re-rod w/cap (set) for reference on the west right-of-way line Glynwood-New Knoxville Road at a distance of 25.00 feet) for a total distance of 1343.01 feet to a 5/8" re-rod w/cap (set) on the west line of the southeast quarter of the northeast quarter;

thence, N 01 degree 22' 18" E (passing through a 5/8" re-rod w/cap set for reference at a distance of 339.57 feet) for a total distance of 389.57 feet to the northwest corner of the southeast quarter of the northeast quarter of Section 18;

thence, along an open ditch, on the north line of the southeast quarter of the northeast quarter of Section 18, for a distance of 1343.16 feet to a cotton gin spindle (set) at the northeast corner of the southeast quarter of the northeast quarter of Section 18 and the legal centerline of Glynwood-New Knoxville Road;

thence, S 01 degree 23' 34" W along the east line of the southeast quarter of the northeast quarter of Section 18 and the legal centerline of Glynwood-New Knoxville Road, for a distance of 389.57 feet to the **POINT OF BEGINNING**, containing therein 12.010 acres, of which 0.224 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
