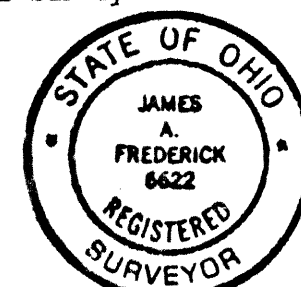
NOTE - There is some doubt as to whether the right-of-way line, in the centerline of Main Street, is the east line of the Outlots. The west line of this property (Barber) is dimensioned 150 feet west of the east line of Outlot 14. The distance in the location of the west property line is 20 feet, if measured from the right-of-way line or centerline. A survey by Frazee & Son, Inc., dated August and September 1956 shows this point to be measured 150 feet from the centerline.
