LEGAL DESCRIPTION

Being a part of Lot One of Ernst Eschmeyer's Subdivision of Lots One and Two of Fred Wiemeyer's Subdivision of the west one-half of the northeast quarter of Section 30, T-6-S, R-5-E, Washington Township, Village of New Knoxville, Auglaize County, Ohio as evidenced by OR 71, Page 69, and more particularly described as follows:

Commencing at a railroad spike (found) at the intersection of the southeast corner of West Haven Subdivision and the centerline of Bremen Street; thence, S 72 degrees 06' 17" W along the centerline of Bremen Street, for a distance of 286.55 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** of the tract herein described;

thence, S 01 degree 04' 18" W (passing through a 5/8" re-rod w/cap set for reference on the southerly right-of-way of Bremen Street at a distance of 21.15 feet) for a total distance of 396.74 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 33' 58" W for a distance of 121.33 feet to a 5/8" re-rod w/cap (set) on the north/south half Section line of Section 30;


thence, N 01 degree 04' 18" E along the aforesaid north/south half section line (passing through a 5/8" re-rod set for reference on the southerly right-of-way line of Bremen Street at a distance of 335.24 feet) for a total distance of 356.39 feet to a p-k nail (found) at the centerline of Bremen Street;

thence, N 72 degrees 06' 17" E along the aforesaid centerline, for a distance of 128.29 feet to the POINT OF BEGINNING, containing therein 1.049 acres, of which 0.059 acres is road right-of-way. thence, S 01 degree 04' 18" W (passing through a 5/8" re-rod w/cap set for reference on the southerly right-of-way of Bremen Street at a distance of 21.15 feet) for a total distance of 431.65 feet to a 5/8" re-rod w/cap (set);

thence, N 89 degrees 33' 58" W for a distance of 105.00 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 04' 18" E (passing through a 5/8" re-rod set for reference on the southerly right-of-way line of Bremen Street at a distance of 375.59 feet) for a total distance of 396.74 feet to a cotton gin spindle (set) at the centerline of Bremen Street;

thence, N 72 degrees 06' 17" E along the aforesaid centerline, for a distance of 111.02 feet to the **POINT OF BEGINNING**, containing therein 0.998 acres, of which 0.051 acres is road right-of-way.
