Tract One Surveyor's Description

Being a part of the northeast quarter of Section 7, Town-5-South, Range-8-East, Wayne Township, Auglaize County, Ohio as evidenced by Official Record Volume 496, Page 811 and more particularly described as follows:

Commencing for reference at a monument box (found) at the northwest corner of the northeast quarter of Section 7 and the legal centerline of Buckland-Holden Road; thence, N 89° 56′ 20″ E along the north line of the northeast quarter of Section 7 and the aforesaid legal centerline for a distance of 200.00 feet to a cotton gin spindle (found), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing N 89° 56′ 20″ E along the aforesaid north line and legal centerline for a distance of 212.21 feet to a cotton gin spindle (found);

thence, S 00° 06′ 10″ E (passing through a 5/8″ re-rod w/cap found on the south right-of-way line of Buckland-Holden Road at a distance of 25.00 feet) for a total distance of 720.66 feet to a 5/8″ re-rod w/cap (found);

thence, S 85° 48′ 12″ W for a distance of 212.71 feet to a 5/8″ re-rod w/cap (found);

thence, N 00° 06′ 23″ W (passing through a 5/8″ re-rod w/cap found at a distance of 711.00 feet) for a total distance of 736.00 feet to the **POINT OF BEGINNING**, containing therein **3.547 acres**, of which 0.121 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument.
