



## SURVEYOR'S DESCRIPTION Parcel Split A - 28.495 Acres

Commencing for reference at a Monument Box (found) situated at the Southeast corner of the Northeast Quarter of said Section 17, Wayne Township, Town-5-South, Range-8-East;

Thence with a bearing of N. 00°-59'-28" E. along the East line of the Northeast Quarter of said Section 17, Wayne Township, and the legal centerline of Moyer Road (Township Road #271), for a distance of 712.80 feet to a 2" Mag Nail (set) and the PLACE OF BEGINNING;

Thence with a bearing of N. 89°-37'-05" W. for a distance of 2,139.45 feet to a point, and passing thru an Iron Pin (set) for reference at a distance of 20.00 feet;

Thence with a bearing of N. 00°-49'-24" E. along the West line of permanent parcel #N41-017-005-01 as referenced by deed OR 623, page 1564, for a distance of 605.27 feet to an Iron Pin (set) located at the Northwest corner of said permanent parcel #N41-017-005-01;

Thence with a bearing of S. 89°-38'-16" E. along the North line of the South half of the Northeast Quarter of said Section 17, Wayne Township, and also being along the North line of permanent parcel #N41-017-005-01 as referenced by deed volume OR 623, page 1564, for a distance of 2,141.23 feet to a 2" Mag Nail (set), and passing thru an Iron Pin (set) for reference at a distance of 2,121.23 feet;

Thence with a bearing of S. 00°-59'-28" W. along the East line of the Northeast Quarter of said Section 17, Wayne Township, and the legal centerline of Moyer Road (Township Road #271), for a distance of 327.81 feet to a Railroad Spike (found);

Thence with a bearing of N. 89°-00′-32″ W. along the North line of permanent parcel #N41-017-005-00 as referenced by deed volume OR 100, page 319, for a distance of 335.00 feet to an Iron Pipe (found), and passing thru an Iron Pipe (found) at a distance of 30.00 feet;

Thence with a bearing of S. 00°-59'-28" W. along the West line of permanent parcel #N41-017-005-00 as referenced by deed volume OR 100, page 319, and also parallel with the East line of the Northeast Quarter of said Section 17, Wayne Township, and the legal centerline of Moyer Road (Township Road #271), for a distance of 164.00 feet to an Iron Pipe (found);

Thence with a bearing of S. 89°-00'-32" E. along the South line of permanent parcel #N41-017-005-00 as referenced by deed volume OR 100, page 319, for a distance of 335.00 feet to a Railroad Spike (found), and passing thru an Iron Pipe (found) at a distance of 305.00 feet;

Thence with a bearing of S. 00°-59'-28" W. along the East line of the Northeast Quarter of said Section 17, Wayne Township, and the legal centerline of Moyer Road (Township Road #271), for a distance of 114.20 feet to a 2" Mag Nail (set) and the original PLACE OF BEGINNING.

Containing in all, 28.495 Acres of land. The above described parcel of land contains approximately 0.203 Acre previously dedicated for highway purposes, and is subject to any or all legal easements, reservations, or restrictions of record upon said premises.

Thence with a bearing of N. 00°-52'-04" E. along the East line of the Southwest Quarter of said Section 17, Wayne Township, for a distance of 1,323.30 feet to a concrete base (found) from an obliterated wood corner post as referenced to in Survey Book G, page 502, and Survey Book J, page 597, Auglaize County Engineer's Map Office, said concrete base (found) being located at the Southeast corner of the North half of the Southwest Quarter of said Section 17, Wayne Township;


