SURVEYOR'S DESCRIPTION

The following tract of land is part of the East Half of the Southeast Quarter of Section 14- T-6-S-R-42 Pusheta Township, Auglaize County, Ohio, and is more particularly described as follows;

Commencing at the Southeast Corner of Southeast Quarter of section 14, Pusheta Township, point being in the centerline of County Road No. 34. Thence in a westerly direction along the centerline of County Road No. 34 a distance of 760.50 feet to a Boat Spike, this being the PLACE OF BEGINNING. Thence continuing in a westerly direction along the centerline of County Road No. 34 a distance of 20.0 feet to a Boat Spike.

Thence in a Northerly direction with an internal angle of $55^{\circ} 37'$ a distance of 864.65 feet to an iron pipe;

Thence in a westerly direction with an internal angle of $277^{\circ} 33'$ a distance of 213.38 feet to a well corner post.

Thence in a Northerly direction with an internal angle of $90^{\circ} 58'$ a distance of 723.40 feet to an iron pipe;

Thence in a Easterly direction with an internal angle of $89^{\circ} 42'$ a distance of 308.98 feet to an iron pipe.

Thence in a Southerly direction with an internal angle of $90^{\circ} 38'$ a distance of 450.30 feet to an iron pipe;

Thence in a westerly direction with an internal angle of $89^{\circ} 25'$ a distance of 73.75 feet to an iron pipe

Thence in a Southerly direction with an internal angle of $269^{\circ} 21'$ a distance of 275.14 feet to a point.

Thence in a Southerly direction with a deflection to the Right of $22^{\circ} 37'$ a distance of 664.30 to the Boat Spike in the Centerline of County Road No. 34 which was the PLACE OF BEGINNING.

The above described Tract of Land Contains 5.07 Acres subject to all Legal Highways and easements of record.
