SURVEY DESCRIPTION TRACT "A"

Being a parcel of land situated in Noble Township, Auglaize County, Ohio, in the southeast quarter of the northwest quarter of Section 19, Town 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at a $\frac{1}{2}$ inch iron bar at the center of said Section 19-

Thence, north $00^{\circ}45'$ east, along the north-south half section line of said Section 19 and the centerline of Koenig Road, a distance of three hundred twenty-four and $80/100$ (324.80) feet to a $5/8$ inch iron bar. Said point being the place of beginning for the parcel to be-conveyed by this instrument-

Thence, continuing north $00^{\circ}45'$ east, along the last described line, a distance of two hundred seventy-eight and $46/100$ (278.46) feet to a $5/8$ inch iron bar-

Thence, north $89^{\circ}15'$ west, a distance of one hundred fifty-six and $43/100$ (156.43) feet to a $5/8$ inch iron bar-

Thence, south $00^{\circ}45'$ west, a distance of two hundred seventy-eight and $46/100$ (278.46) feet to a $5/8$ inch iron bar-

Thence, south $89^{\circ}15'$ east, a distance of one hundred fifty-six and $43/100$ (156.43) feet to the place of beginning.

Containing 1.000 acre of land more or less.

Subject to all easements and right-of-way of record.

The north-south half section line of Section 19 was assumed to bear north $00^{\circ}45'$ east. All other bearings were calculated from angles turned.
