## SURVETORS DESCRIPTION

The following tract of land is part of the Northwest Lugrter of Section 17, Wayne Township, T-5-S-R-8-E with respect to the First Principal Meridian, Auglaize County, Ohio, and is more particularly described as follows.

Commencing at the Northwest corner of Section 17, said point being the point of intersection of the centerlines of State Route No. 196 (SR-196) and County Road no. 180 (CR-180) also known as Fairmount Road; Thence South Ou 30'E, along the centerline of SR-196 a distance of 1703.45 feet to a capped nail which is the PLACE OF BEGINNING.

Thence continuing South 00  $^{\circ}$  30  $^{\circ}$ E along the centerline of SR-196 a distance of 100.00 feet to a capped nail.

Thence North 89 225'E (thorugh an iron pipe set at the 30.00 feet right of way line) a total distance of 230.0 feet to an iron pipe.

Thence North 00 2 30 W, a distance of 100.00 feet to an iron pipe.

Thence South 89 2 25 W (through an iron pipe at the 30.0 feet right of way line) a total distance of 230.00 feet to the capped nail which was the PLACE OF BEGINNING.

The above described tract of land contains 0.52 acres more or less subject to all legal highways and easements of record.
