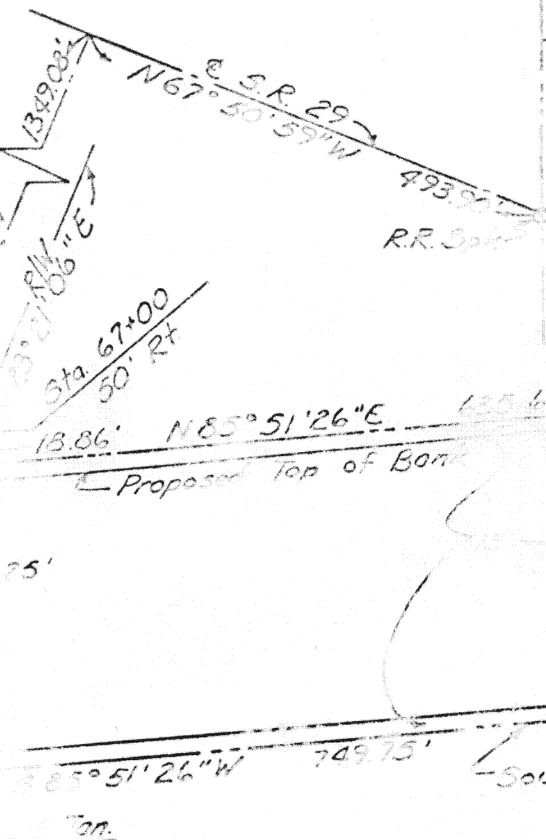

South Line, Section 2

A tract of land situated in the Southwest Quarter of Section 2, St. Marys Township, Auglaize County, Ohio, more particularly as follows:

Beginning at the intersection of the East line of the Southwest Quarter of said Section 2 and the East line of State Route 29; thence N 67° 50' 59" W with the centerline of State Route 29 to the intersection with the centerline of the Greenville Road; thence S 23° 21' 06" W with the centerline of the Greenville Road, 1349.08 feet; thence S 85° 51' 26" E to the east Right-of-Way line of said Greenville Road and the East line of Section 2; thence N 85° 51' 26" E, 135.40 feet; thence S 00° 00' 00" E, 315.25 feet to the South line of Section 2; thence N 85° 51' 26" W with the south line of Section 2 to the east Right-of-Way line of said Greenville Road; thence S 85° 51' 26" W to the PLACE OF BEGINNING containing 217,796 square feet or thereabouts more or less and subject to all legal easements and rights-of-way of record.
