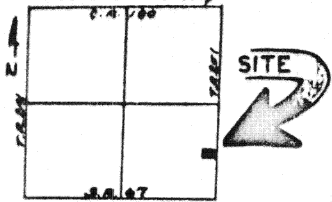


LOCATION PLAN

The following tract of land is part of the southeast quarter of Section 13, Union Township, Township Five (5) South, Range Seven (7) East, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a P.K. Nail found in the Northeast corner of the southeast quarter of Section 13, Union Township, said nail being in the centerline of Township Road #251 (T.R.251 formerly known as the Santa Fe Road); thence S.00°00'E. along the east line of Section 13 and the centerline of T.R.#251 a distance of 642.15 feet to an existing Spike being the Place of Beginning; thence continuing S.00°00'E. along said centerline and east line of Section 13 a distance of 157.23 feet to an existing P.K. Nail; thence N.89°53'20"W. through an existing iron pin at 25.00 feet in the west right-of-way line of T.R.#251 for a total distance of 277.05 feet to an iron pin; thence N.00°00'W. a distance of 157.23 feet to an iron pin; thence S.89°53'20"E. through an existing iron pin in the west right-of-way line of T.R.#251 for a total distance of 277.05 feet to a spike and the Place of Beginning.

The above described tract of land contains 1.00 Acres and is subject to all legal easements and rights-of-ways.
