

## Description:

Being a parcel of land situated in the southwest quarter of Section 22, T 6 S, R 4 E, St. Marys Township, Auglaize County, Ohio, and more fully described as follows:

Beginning at a point (said point being the intersection of centerlines for the Western Ohio Railroad and the State Route No. 219 marked with a R.R. Spike and located S 89° 30' E a distance of 1325.83' from the southwest corner of the southwest quarter of Section 22);

thence N 00° 21' E along the Western Ohio Railroad centerline for a distance of 2500.19' to an iron pin;

thence S 89° 30' E for a distance of 301.75' to an iron pin passing through an iron pin set at 50.00' marking the railroad east right of way line;

thence N 88° 15' W for a distance of 278.20' to a 6" round wood fence post;

thence S 02° 08' W for a distance of 155.12' to an iron pin;

thence S 52° 40' W for a distance of 239.40' to an iron pin;

thence S 39° 45' W for a distance of 289.20' to an iron pin;

thence S 00° 21' W for a distance of 417.20' to an iron pin;

thence N 89° 27' W for a distance of 595.80' to an iron pin;

thence S 00° 21' W parallel to the east right of way line for the Western Ohio Railroad and 20.00' east of said line for a distance of 1457.31' to a R. R. Spike
on the centerline of St. Rte. No. 219 passing through an iron pin at 1427.31'
marking the north right of way line for St. Rte. No. 219;

thence N 89° 30' W along the centerline of St. Rte. No. 219 for a distance of 70.00' to the R. R. Spike at the point of beginning.

Said parcel of land contains 21.280 acres, more or less, and is subject to all legal highways consisting of .014 acre and also the railroad right of way easement consisting of 2.870 acres, and finally all easements of record.
